

HOUSE BILL No. 4351

March 14, 2017, Introduced by Reps. Kahle, Lucido, LaSata, Marino, Noble, Iden and Kesto
and referred to the Committee on Tax Policy.

A bill to amend 1933 PA 167, entitled
"General sales tax act,"
by amending section 4x (MCL 205.54x), as amended by 2009 PA 53.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4x. (1) A sale to a domestic air carrier of 1 or more of
2 the following is exempt from the tax under this act:

3 (a) An aircraft that has a maximum certificated takeoff weight
4 of at least 6,000 pounds for use solely in the transport of air
5 cargo, passengers, or a combination of air cargo and passengers.

6 (b) Parts and materials, excluding shop equipment or fuel,
7 affixed or to be affixed to an aircraft that has a maximum
8 certificated takeoff weight of at least 6,000 pounds for use solely
9 in the transport of air cargo, passengers, or a combination of air

1 cargo and passengers.

2 (2) The tax levied under this act does not apply to the sale
3 of parts or materials, excluding shop equipment or fuel, affixed or
4 to be affixed to ~~an aircraft that meets all of the following~~
5 ~~conditions:~~ **A GENERAL AVIATION AIRCRAFT.**

6 ~~— (a) The aircraft leaves this state within 15 days after the~~
7 ~~sooner of the issuance of the final billing or authorized approval~~
8 ~~for final return to service, completion of the maintenance record~~
9 ~~entry, and completion of the test flight and ground test for~~
10 ~~inspection as required under 14 CFR 91.407.~~

11 ~~— (b) The aircraft was not based in this state or registered in~~
12 ~~this state before the parts or materials are affixed to the~~
13 ~~aircraft and the aircraft is not based in this state or registered~~
14 ~~in this state after the parts or materials are affixed to the~~
15 ~~aircraft.~~

16 (3) The tax levied under this act does not apply to the sale
17 of an aircraft temporarily located in this state for the purpose of
18 a sale and prepurchase evaluation, customization, improvement,
19 maintenance, or repair if all of the following conditions are
20 satisfied:

21 (a) The aircraft leaves this state within 15 days after the
22 sale and the completion of any prepurchase evaluation,
23 customization, improvement, maintenance, or repair that is
24 associated with the sale, whichever is later.

25 (b) The aircraft was not based in this state or registered in
26 this state before the sale and any prepurchase evaluation,
27 customization, improvement, maintenance, or repair that is

1 associated with the sale is completed and the aircraft is not based
2 in this state or registered in this state after the sale and any
3 prepurchase evaluation, customization, improvement, maintenance, or
4 repair that is associated with the sale is completed.

5 (4) A sale of an aircraft to a person for subsequent lease to
6 a domestic air carrier operating under a certificate issued by the
7 federal aviation administration under 14 CFR 121, for use solely in
8 the regularly scheduled transport of passengers is exempt from the
9 tax under this act.

10 (5) As used in this section:

11 (a) "Based in this state" means hangared or stored in this
12 state for not less than 10 days in not less than 3 nonconsecutive
13 months during the immediately preceding 12-month period.

14 (b) "Customization" means any improvement, maintenance, or
15 repair that is performed on an aircraft that is associated with the
16 sale of the aircraft.

17 (c) "Domestic air carrier" is limited to entities engaged
18 primarily in the commercial transport for hire of air cargo,
19 passengers, or a combination of air cargo and passengers as a
20 business activity.

21 **(D) "GENERAL AVIATION AIRCRAFT" MEANS AN AIRCRAFT THAT IS USED**
22 **IN CIVIL AVIATION, BUT DOES NOT INCLUDE AN UNMANNED AERIAL VEHICLE.**

23 **(E)** ~~(d)~~ "Prepurchase evaluation" means an examination of an
24 aircraft to provide a potential purchaser with information relevant
25 to the potential purchase.

26 **(F)** ~~(e)~~ "Registered in this state" means an aircraft
27 registered with the state transportation department, bureau of

1 aeronautics or registered with the ~~federal aviation administration~~
2 **FEDERAL AVIATION ADMINISTRATION** to an address located in this
3 state.

4 Enacting section 1. This amendatory act takes effect 90 days
5 after the date it is enacted into law.
