A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 20210 and 20210a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 20210. (1) THE DEPARTMENT SHALL ESTABLISH AND MAINTAIN A

- (B) THE DAYS AND GENERAL HOURS OF OPERATION OF EACH HEALTH

 - 1 EXPIRATION DATE OF EACH HEALTH FACILITY OR AGENCY.

- 27 SEC. 20210A. (1) A MUNICIPALITY SHALL NOTIFY THE DEPARTMENT IF

- 1 A HEALTH FACILITY OR AGENCY VIOLATES AN ORDINANCE OF THE
- 2 MUNICIPALITY THAT INVOLVES HEALTH OR SAFETY. THE DEPARTMENT SHALL
- 3 USE THE INFORMATION OBTAINED IN THIS SECTION FOR THE PURPOSE OF
- 4 UPDATING THE DATABASE ESTABLISHED IN SECTION 20210.
- 5 (2) AS USED IN THIS SECTION, "MUNICIPALITY" MEANS A COUNTY,
- 6 CITY, VILLAGE, OR TOWNSHIP.
- 7 Enacting section 1. This amendatory act takes effect 90 days
- 8 after the date it is enacted into law.
