HOUSE BILL No. 4538

April 26, 2017, Introduced by Rep. Lucido and referred to the Committee on Law and Justice.

A bill to amend 1925 PA 289, entitled

"An act to create and maintain a fingerprint identification and criminal history records division within the department of state police; to require peace officers, persons in charge of certain institutions, and others to make reports respecting juvenile offenses, crimes, and criminals to the state police; to require the fingerprinting of an accused by certain persons; and to provide penalties and remedies for a violation of this act,"

by amending section 3 (MCL 28.243), as amended by 2012 PA 374.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 3. (1) Except as provided in subsection (3), upon the arrest of a person for a felony or for a misdemeanor violation of state law for which the maximum possible penalty exceeds 92 days' imprisonment or a fine of \$1,000.00, or both, or a misdemeanor authorized for DNA collection under section 6(1)(b) of the DNA

- 1 identification profiling system act, 1990 PA 250, MCL 28.176, or
- 2 for criminal contempt under section 2950 or 2950a of the revised
- 3 judicature act of 1961, 1961 PA 236, MCL 600.2950 and 600.2950a, or
- 4 criminal contempt for a violation of a foreign protection order
- 5 that satisfies the conditions for validity provided in section
- 6 2950i of the revised judicature act of 1961, 1961 PA 236, MCL
- 7 600.2950i, or for a juvenile offense, other than a juvenile offense
- 8 for which the maximum possible penalty does not exceed 92 days'
- 9 imprisonment or a fine of \$1,000.00, or both, or for a juvenile
- 10 offense that is a misdemeanor authorized for DNA collection under
- 11 section 6(1)(b) of the DNA identification profiling system act,
- 12 1990 PA 250, MCL 28.176, the arresting law enforcement agency in
- 13 this state shall collect the person's biometric data and forward
- 14 the biometric data to the department within 72 hours after the
- 15 arrest. The biometric data shall be sent to the department on forms
- 16 furnished by or in a manner prescribed by the department, and the
- 17 department shall forward the biometric data to the director of the
- 18 federal bureau FEDERAL BUREAU of investigation INVESTIGATION on
- 19 forms furnished by or in a manner prescribed by the director.
- 20 (2) A law enforcement agency shall collect a person's
- 21 biometric data under this subsection if the person is arrested for
- 22 a misdemeanor violation of state law for which the maximum penalty
- 23 is 93 days or for criminal contempt under section 2950 or 2950a of
- 24 the revised judicature act of 1961, 1961 PA 236, MCL 600.2950 and
- 25 600.2950a, or criminal contempt for a violation of a foreign
- 26 protection order that satisfies the conditions for validity
- 27 provided in section 2950i of the revised judicature act of 1961,

- 1 1961 PA 236, MCL 600.2950i, if the biometric data have not
- 2 previously been collected and forwarded to the department under
- 3 subsection (1). A law enforcement agency shall collect a person's
- 4 biometric data under this subsection if the person is arrested for
- 5 a violation of a local ordinance for which the maximum possible
- 6 penalty is 93 days' imprisonment and that substantially corresponds
- 7 to a violation of state law that is a misdemeanor for which the
- 8 maximum possible term of imprisonment is 93 days. If the person is
- 9 convicted of any violation, the law enforcement agency shall
- 10 collect the person's biometric data before sentencing if not
- 11 previously collected. The court shall forward to the law
- 12 enforcement agency a copy of the disposition of conviction, and the
- 13 law enforcement agency shall forward the person's biometric data
- 14 and the copy of the disposition of conviction to the department
- 15 within 72 hours after receiving the disposition of conviction in
- 16 the same manner as provided in subsection (1). If the person is
- 17 convicted of violating a local ordinance, the law enforcement
- 18 agency shall indicate on the form sent to the department the
- 19 statutory citation for the state law to which the local ordinance
- 20 substantially corresponds.
- 21 (3) A person's biometric data are not required to be collected
- 22 and forwarded to the department under subsection (1) or (2) solely
- 23 because he or she has been arrested for violating section 904(3)(a)
- 24 of the Michigan vehicle code, 1949 PA 300, MCL 257.904, or a local
- 25 ordinance substantially corresponding to section 904(3)(a) of the
- 26 Michigan vehicle code, 1949 PA 300, MCL 257.904.
- 27 (4) The arresting law enforcement agency may collect the

- 1 biometric data of a person who is arrested for a misdemeanor
- 2 punishable by imprisonment for not more than 92 days or a fine of
- 3 not more than \$1,000.00, or both, and who fails to produce
- 4 satisfactory evidence of identification as required by section 1 of
- 5 1961 PA 44, MCL 780.581. These biometric data shall be forwarded to
- 6 the department immediately. Upon completion of the identification
- 7 process by the department, the biometric data shall be destroyed.
- **8** (5) An arresting law enforcement agency in this state may
- 9 collect the person's biometric data upon an arrest for a
- 10 misdemeanor other than a misdemeanor described in subsection (1),
- 11 (2), or (4), and may forward the biometric data to the department.
- 12 (6) If a court orders the collection of a person's biometric
- 13 data under section 11 or 18 of chapter XIIA of the probate code of
- 14 1939, 1939 PA 288, MCL 712A.11 and 712A.18, or section 29 of
- 15 chapter IV or section 1 of chapter IX of the code of criminal
- 16 procedure, 1927 PA 175, MCL 764.29 and 769.1, the law enforcement
- 17 agency shall forward the biometric data and arrest card to the
- 18 department.
- 19 (7) If a petition is not authorized for a juvenile accused of
- 20 a juvenile offense, if a person arrested for having committed an
- 21 offense for which biometric data were collected under this section
- 22 is released without a charge made against him or her, or if
- 23 criminal contempt proceedings are not brought or criminal charges
- 24 are not made against a person arrested for criminal contempt for a
- 25 personal protection order violation under section 2950 or 2950a of
- 26 the revised judicature act of 1961, 1961 PA 236, MCL 600.2950 and
- 27 600.2950a, or criminal contempt for a violation of a foreign

- 1 protection order that meets the requirements for validity under
- 2 section 2950i of the revised judicature act of 1961, 1961 PA 236,
- **3** MCL 600.2950i, the official taking or holding the person's
- 4 biometric data and arrest card shall immediately destroy the
- 5 biometric data and arrest card. The law enforcement agency shall
- 6 notify the department in a manner prescribed by the department that
- 7 a petition was not authorized against the juvenile or that a charge
- 8 was not made or that a criminal contempt proceeding was not brought
- 9 against the arrested person if the juvenile's or arrested person's
- 10 arrest card was forwarded to the department.
- 11 (8) IF AN INDIVIDUAL IS ARRESTED FOR ANY CRIME AND THE
- 12 COMPLAINING WITNESS RECANTS HIS OR HER STATEMENT, AFFIDAVIT, OR
- 13 TESTIMONY ALLEGING THAT THE INDIVIDUAL COMMITTED 1 OR MORE OFFENSES
- 14 AGAINST THE WITNESS BEFORE TRIAL IS HELD IN THE MATTER, AND THE
- 15 CHARGE IS DISMISSED BEFORE TRIAL, BOTH OF THE FOLLOWING APPLY:
- 16 (A) THE ARREST RECORD, ALL BIOMETRIC DATA, AND FINGERPRINTS
- 17 SHALL BE EXPUNGED OR DESTROYED, OR BOTH, AS APPROPRIATE.
- 18 (B) ANY ENTRY CONCERNING THE CHARGE AND THE INDIVIDUAL SHALL
- 19 BE REMOVED FROM THE LEIN.
- 20 (9) THE DEPARTMENT SHALL COMPLY WITH THE REQUIREMENTS LISTED
- 21 IN SUBSECTION (8) UPON RECEIPT OF AN APPROPRIATE ORDER ISSUED BY
- 22 THE DISTRICT COURT OR THE CIRCUIT COURT.
- 23 (10) (8)—If a juvenile is adjudicated and found not to be
- 24 within the provisions of section 2(a)(1) of chapter XIIA of the
- 25 probate code of 1939, 1939 PA 288, MCL 712A.2, or if an accused is
- 26 found not quilty of an offense for which biometric data were
- 27 collected under this section, upon final disposition of the charge

- 1 against the accused or juvenile, the biometric data and arrest card
- 2 shall be destroyed by the official holding those items and the
- 3 clerk of the court entering the disposition shall notify the
- 4 department of any finding of not guilty or nolle prosequi, if it
- 5 appears that the biometric data of the accused were initially
- 6 collected under this section, or of any finding that a juvenile
- 7 alleged responsible for a juvenile offense is not within the
- 8 provisions of section 2(a)(1) of chapter XIIA of the probate code
- 9 of 1939, 1939 PA 288, MCL 712A.2.
- 10 (11) (9) Upon final disposition of the charge against the
- 11 accused, the clerk of the court entering the disposition shall
- 12 immediately advise the department of the final disposition of the
- 13 arrest for which the person's biometric data were collected if a
- 14 juvenile was adjudicated to have committed a juvenile offense or if
- 15 the accused was convicted of an offense for which the biometric
- 16 data of the accused were collected under this section or section
- 17 16a of chapter IX of the code of criminal procedure, 1927 PA 175,
- 18 MCL 769.16a. With regard to any adjudication or conviction, the
- 19 clerk shall transmit to the department information as to any
- 20 adjudication or finding of guilty or guilty but mentally ill; any
- 21 plea of guilty, nolo contendere, or guilty but mentally ill; the
- 22 offense of which the accused was convicted; and a summary of any
- 23 deposition or sentence imposed. The summary of the sentence shall
- 24 include any probationary term; any minimum, maximum, or alternative
- 25 term of imprisonment; the total of all fines, costs, and
- 26 restitution ordered; and any modification of sentence. If the
- 27 sentence is imposed under any of the following sections, the report

- 1 shall so indicate:
- 2 (a) Section 7411 of the public health code, 1978 PA 368, MCL
- **3** 333.7411.
- 4 (b) Section 1076(4) of the revised judicature act of 1961,
- 5 1961 PA 236, MCL 600.1076.
- 6 (c) Sections 11 to 15 of chapter II of the code of criminal
- 7 procedure, 1927 PA 175, MCL 762.11 to 762.15.
- 8 (d) Section 4a of chapter IX of the code of criminal
- 9 procedure, 1927 PA 175, MCL 769.4a.
- 10 (e) Section 350a(4) of the Michigan penal code, 1931 PA 328,
- **11** MCL 750.350a.
- 12 (f) Section 430(8)(a) 430(9)(A) of the Michigan penal code,
- 13 1931 PA 328, MCL 750.430.
- 14 (g) Section $\frac{1209(6)}{1209(7)}$ of the revised judicature act of
- 15 1961, 1961 PA 236, MCL 600.1209.
- 16 (12) (10) The department shall record the disposition of each
- 17 charge and shall inform the director of the federal bureau of
- 18 investigation of the final disposition of any arrest or offense for
- 19 which a person's biometric data were collected under this section
- 20 or section 16a of chapter IX of the code of criminal procedure,
- 21 1927 PA 175, MCL 769.16a.
- 22 (13) (11)—The department shall compare the biometric data
- 23 received with those already on file and if the department finds
- 24 that the person arrested has a criminal record, the department
- 25 shall immediately inform the arresting agency and prosecuting
- 26 attorney of this fact.
- 27 (14) (12) The EXCEPT AS PROVIDED IN SUBSECTION (8), THE

- 1 provisions of subsection $\frac{(8)}{(10)}$ that require the destruction of
- 2 the biometric data and the arrest card do not apply to a person who
- 3 was arraigned for any of the following:
- 4 (a) The commission or attempted commission of a crime with or
- 5 against a child under 16 years of age.
- **6** (b) Rape.
- 7 (c) Criminal sexual conduct in any degree.
- 8 (d) Sodomy.
- 9 (e) Gross indecency.
- 10 (f) Indecent liberties.
- 11 (g) Child abusive commercial activities.
- 12 (h) A person who has a prior conviction, other than a
- 13 misdemeanor traffic offense, unless a judge of a court of record,
- 14 except the probate court, by express order on the record, orders
- 15 the destruction or return of the biometric data and arrest card.
- (i) A person arrested who is a juvenile charged with an
- 17 offense that would constitute the commission or attempted
- 18 commission of any of the crimes in this subsection if committed by
- 19 an adult.
- 20 (15) (13)—Subsection (5) does not permit the forwarding to the
- 21 department of the biometric data of a person accused and convicted
- 22 under the Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923,
- 23 or a local ordinance substantially corresponding to a provision of
- 24 that act, unless the offense is punishable upon conviction by
- 25 imprisonment for more than 92 days or is an offense that is
- 26 punishable by imprisonment for more than 92 days upon a subsequent
- 27 conviction.

- Enacting section 1. This amendatory act takes effect 90 daysafter the date it is enacted into law.
- 3 Enacting section 2. This amendatory act does not take effect
- 4 unless both of the following bills of the 99th Legislature are
- 5 enacted into law:
