A bill to amend 1846 RS 16, entitled

"Of the powers and duties of townships, the election and duties of township officers, and the division of townships,"

(MCL 41.1a to 41.110c) by adding section 3b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3B. (1) A TOWNSHIP MAY PROVIDE BY ORDINANCE A PROCEDURE
- 2 TO FINANCE BY SPECIAL ASSESSMENTS THE PROVISION OF MOSQUITO
- 3 ABATEMENT BY PRIVATE CONTRACTORS. THE ORDINANCE MUST AUTHORIZE THE
- 4 TOWNSHIP BOARD TO INITIATE THE ESTABLISHMENT OF A SPECIAL
- 5 ASSESSMENT DISTRICT UNDER THIS SECTION BY RESOLUTION. IN ADDITION,
- 6 THE ORDINANCE MUST AUTHORIZE THE USE OF PETITIONS TO INITIATE THE
- 7 ESTABLISHMENT OF A SPECIAL ASSESSMENT DISTRICT UNDER THIS SECTION.

- Enacting section 1. This amendatory act takes effect 90 days
- 24 after the date it is enacted into law.
