- SEC. 136A. (1) A PERSON SHALL NOT KNOWINGLY TRANSPORT A PERSON
 FROM THIS STATE FOR THE PURPOSE OF CONDUCT WITH REGARD TO THAT
 PERSON THAT WOULD BE A VIOLATION OF SECTION 136 IF THE CONDUCT
 OCCURRED IN THIS STATE.
 - (2) A PERSON SHALL NOT KNOWINGLY FACILITATE A VIOLATION OF SUBSECTION (1).
 - (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 15 YEARS OR A FINE OF NOT MORE THAN \$25,000.00, OR BOTH.
