THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 733. (1) Except as otherwise provided in this section, this article does not apply in the jurisdiction of a municipality that adopts or has adopted an ordinance that does all of the following:

- (a) Provides standards for the examination and licensing of master electricians, electrical or specialty contractors, electrical journeymen, sign specialists, and fire alarm specialty technicians and the registration of apprentice electricians and fire alarm specialty apprentice technicians that are at least as stringent as those established in this article.
 - (b) Provides for enforcement that is substantially similar to

- 2 (c) Provides for civil and criminal penalties and a citation
- 3 system for minor violations substantially similar to article 5.
- 4 (d) Provides for the inspection of electrical wiring and
- 5 equipment.
- **6** (2) This article shall not be construed as limiting the power
- 7 of a municipality to enact an ordinance described in subsection
- 8 (1), to provide for the licensing of persons as electrical or
- 9 specialty contractors that have a place of business located in the

- 15 580, MCL 338.2182, or section 2 of the private security business
- 16 and security alarm act, 1968 PA 330, MCL 338.1052.
- 17 (d) The procurement of public liability insurance in excess of
- 18 the coverage required under this article.
- 19 (3) A license or registration issued by the board under this
- 20 article and licenses issued by a municipality that has standards
- 21 for licensing at least as stringent as those established by the
- 22 board shall be recognized by all municipalities.
- 23 (4) A municipality that provides for electrical inspection by
- 24 local ordinance may require all electrical or specialty
- 25 contractors, sign specialists, fire alarm specialty technicians,
- 26 and classes of electricians doing work in the municipality to
- 27 register in accordance with its local ordinance.

- 1 (5) Municipal registration requirements shall be reciprocal
- 2 between the municipalities and between municipalities and the board
- 3 as to registration requirements and fees, except that licensed
- 4 electrical journeymen, sign specialists, and fire alarm specialty
- 5 technicians are not required to register to work in municipalities
- 6 under the jurisdiction of the board. A municipality shall
- 7 officially recognize a license or registration issued under this
- 8 article for purposes of its ordinance.
- 9 Enacting section 1. This amendatory act takes effect 90 days
- 10 after the date it is enacted into law.
