A bill to amend 1984 PA 431, entitled "The management and budget act,"

(MCL 18.1101 to 18.1594) by adding section 266.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 266. (1) THE DEPARTMENT SHALL DEVELOP A PROTEST PROCESS

- 6 REQUESTS FOR PROPOSALS ISSUED BY THE DEPARTMENT.
 - (3) THE PROTEST PROCESS DEVELOPED BY THE DEPARTMENT SHALL

 - (A) THE TIME AND MANNER IN WHICH THE UNSUCCESSFUL BIDDER MUST

- 2 (C) THE SPECIFIC STATUTE, PROCUREMENT POLICY, OR SOLICITATION
- 3 INSTRUCTION THAT WAS VIOLATED IN THE AWARD DECISION.
- 4 (D) IF THE PROTEST PROCESS PROVIDES FOR A PROTEST PERIOD
- 5 EXTENSION, THEN OBTAINING INFORMATION UNDER THE FREEDOM OF
- 6 INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246, IS NOT A VALID
- 7 REASON FOR A PROTEST PERIOD EXTENSION.
- 8 (4) THE FOLLOWING ACTIONS OF A BIDDER DO NOT CONSTITUTE A
- 9 VALID REASON FOR PROTESTING AN AWARD:
- 10 (A) FAILURE OF A BIDDER TO PROPERLY FOLLOW SOLICITATION
- 11 SUBMISSION INSTRUCTIONS.
- 12 (B) FAILURE OF A BIDDER TO SUBMIT THE BID TO THE DEPARTMENT BY
- 13 THE DUE DATE AND TIME.
- 14 (C) FAILURE OF A BIDDER TO PROVIDE MANDATORY SAMPLES,
- 15 DESCRIPTIVE LITERATURE, OR OTHER REQUIRED DOCUMENTS BY THE DATE AND
- 16 TIME SPECIFIED.
- 17 (D) FAILURE OF A BIDDER TO PROVIDE A REQUIRED DEPOSIT OR
- 18 PERFORMANCE BOND BY THE DATE AND TIME SPECIFIED.
- 19 (E) FAILURE OF A BIDDER TO SUBMIT A PROTEST WITHIN THE TIME
- 20 STIPULATED IN THE SOLICITATION REQUEST FOR PROPOSAL.
- 21 (5) THE CHIEF PROCUREMENT OFFICER OR HIS OR HER DESIGNEE SHALL
- 22 INVESTIGATE AND PROVIDE A WRITTEN RESPONSE TO THE PROTESTING PARTY
- 23 TO ALL PROTESTS THAT MEET THE REQUIREMENTS OF THIS SECTION. UNTIL
- 24 ISSUING A FINAL DECISION ON A TIMELY PROTEST, THE DEPARTMENT WILL
- 25 NOT FINALIZE AN AWARD OF A CONTRACT OR PURCHASE ORDER PURSUANT TO A
- 26 DISPUTED SOLICITATION. HOWEVER, IF THERE IS A THREAT TO PUBLIC
- 27 HEALTH, SAFETY, OR WELFARE, OR DANGER OF IMMEDIATE AND SUBSTANTIAL

- 1 HARM TO STATE PROPERTY FROM DELAY IN MAKING AN AWARD, THE CHIEF
- 2 PROCUREMENT OFFICER MAY PROCEED WITH AN AWARD AND DOCUMENT THE
