HOUSE BILL No. 4832

July 12, 2017, Introduced by Rep. Reilly and referred to the Committee on Appropriations.

A bill to amend 1986 PA 102, entitled

"An act to establish a grant program for certain part-time, independent students in this state; and to prescribe the powers and duties of certain state agencies and institutions of higher education,"

by amending section 3 (MCL 390.1283), as amended by 2004 PA 180.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. A person is eligible to participate in the grant

 - (a) Is a part-time student.
 - (b) Is an independent student.
 - (c) Has not been enrolled in a high school diploma program
 - other than general educational development (GED) A HIGH SCHOOL
 - EQUIVALENCY TEST PREPARATION PROGRAM or adult education for at
- 8 least the 2 preceding years.
 - (d) Is enrolled or accepted for enrollment in an undergraduate

- 1 program of not less than 9 months duration leading to a degree or
- 2 certificate from a Michigan degree granting educational institution
- 3 that is approved by the department of labor and economic
- 4 growth.DEGREE- OR CERTIFICATE-GRANTING POSTSECONDARY EDUCATIONAL
- 5 INSTITUTION IN THIS STATE.
- 6 (e) Has resided continuously in this state for the immediately
- 7 preceding 12 months and is not considered a resident of any other
- 8 state.
- 9 (f) Is not incarcerated in a corrections institution.
