A bill to amend 2006 PA 479, entitled

"Michigan promise grant act,"

by amending section 4 (MCL 390.1624), as amended by 2008 PA 517.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4. (1) The Michigan promise grant program is established.

 The department shall provide Michigan promise grants under this act

 from the trust fund and administer the Michigan promise grant
 - (2) Subject to subsection (3), each student who becomes a high school graduate in or after the 2006-2007 academic year is eligible for the award of a Michigan promise grant in an amount determined under section 5 or 6.
 - (3) In addition to the requirements set forth in subsection(2), the department must find that a student meets all of thefollowing eligibility requirements to award the student a Michigan
