

HOUSE BILL No. 4834

July 12, 2017, Introduced by Rep. Runestad and referred to the Committee on Appropriations.

A bill to amend 2006 PA 479, entitled
"Michigan promise grant act,"
by amending section 4 (MCL 390.1624), as amended by 2008 PA 517.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4. (1) The Michigan promise grant program is established.
2 The department shall provide Michigan promise grants under this act
3 from the trust fund and administer the Michigan promise grant
4 program.

5 (2) Subject to subsection (3), each student who becomes a high
6 school graduate in or after the 2006-2007 academic year is eligible
7 for the award of a Michigan promise grant in an amount determined
8 under section 5 or 6.

9 (3) In addition to the requirements set forth in subsection
10 (2), the department must find that a student meets all of the
11 following eligibility requirements to award the student a Michigan

1 promise grant under this act:

2 **(A) THE STUDENT IS A UNITED STATES CITIZEN OR ANY OTHER**
3 **STUDENT DESCRIBED AS ELIGIBLE TO RECEIVE TITLE IV, HEA PROGRAM**
4 **ASSISTANCE UNDER 34 CFR 668.33.**

5 **(B)** ~~(a)~~—The department has received a completed application
6 for payment as described in section 7(1), including the
7 certification described in section 7(2) or (3), if applicable, on
8 or before November 15 of the state fiscal year in which they are
9 eligible to receive payment.

10 **(C)** ~~(b)~~—The student is a high school graduate and a resident
11 of this state.

12 **(D)** ~~(c)~~—The student meets 1 of the following:

13 (i) For a grant under section 5, the student was awarded an
14 associate's degree or a 2-year certificate of completion in a
15 vocational training program at an approved postsecondary
16 educational institution, completed a comparable vocational
17 education program approved by the department at an approved
18 postsecondary educational institution, or completed 50% or more of
19 the academic requirements for the award of a bachelor's degree at
20 an approved postsecondary educational institution within 4 years of
21 his or her initial enrollment in an approved postsecondary
22 educational institution and meets 1 of the following:

23 (A) Has a cumulative grade point average of at least 2.5.

24 (B) If the student completed a vocational education program
25 that does not record grades or grade point averages for its
26 students, has successfully completed that program.

27 (ii) For a grant under section 6, the student received a

qualifying score in each of the reading, writing, mathematics, science, and social studies components of the state assessment test, and for each student who becomes a high school graduate in or after the 2010-2011 academic year, successfully completes at least 3 credits in mathematics and 3 credits in social science as described in section 1278a(1)(a) of the revised school code, 1976 PA 451, MCL 380.1278a, and 3 credits in science as described in section 1278b(1)(b) of the revised school code, 1976 PA 451, MCL 380.1278b.

(E) ~~(d)~~—The student took the state assessment test.

(F) ~~(e)~~—The student enrolled in an approved postsecondary educational institution within 2 years after he or she became a high school graduate. The department shall extend the 2-year period if the student becomes a member of the United States ~~armed forces~~ **ARMED FORCES** or ~~peace corps~~ **PEACE CORPS** during the 2-year period.

(G) ~~(f)~~—The student did not previously receive a grant under this act or scholarship money under the Michigan merit award scholarship act, 1999 PA 94, MCL 390.1451 to 390.1459.

(H) ~~(g)~~—The student meets any additional eligibility requirements established by the department.

Enacting section 1. This amendatory act does not take effect unless all of the following bills of the 99th Legislature are enacted into law:
