August 16, 2017, Introduced by Rep. Lucido and referred to the Committee on Insurance.

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2677) by adding section 728a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 728A. (1) A FIRM ENGAGED IN THE PRACTICE OF PUBLIC
- 2 ACCOUNTING IN THIS STATE SHALL NOT PERFORM ATTEST OR COMPILATION
- 3 SERVICES FOR PUBLIC BODIES UNLESS IT MEETS ALL OF THE FOLLOWING:
 - (A) HOLDS A MICHIGAN LICENSE UNDER THIS PART.
- 5 (B) PROVIDES A SURETY BOND TO THE DEPARTMENT THAT MEETS ALL OF 6 THE FOLLOWING:
 - (i) IS ISSUED BY A BONDING COMPANY OR INSURANCE COMPANY AUTHORIZED TO DO BUSINESS IN THIS STATE.
 - (ii) EXPIRES AFTER THE DATE THE FIRM'S LICENSE EXPIRES.

- 11 (i) IS ISSUED BY AN INSURER THAT IS AUTHORIZED TO TRANSACT
- 12 BUSINESS IN THIS STATE.
- 13 (ii) IS APPROVED BY THE DEPARTMENT.
- 14 (iii) IS IN AN AMOUNT OF AT LEAST \$25,000,000.00, AS
- 15 DETERMINED BY THE FIRM.
- 16 (2) AS USED IN THIS SECTION, "PUBLIC BODY" MEANS 1 OR MORE OF
- 17 THE FOLLOWING:
- 18 (A) A STATE AGENCY, DEPARTMENT, DIVISION, BUREAU, BOARD,
- 19 COMMISSION, COUNCIL, AUTHORITY, OR OTHER BODY IN THE EXECUTIVE
- 20 BRANCH OF STATE GOVERNMENT.
- 21 (B) THE LEGISLATURE OR AN AGENCY, BOARD, COMMISSION, OR
- 22 COUNCIL IN THE LEGISLATIVE BRANCH OF STATE GOVERNMENT.
- 23 (C) A COUNTY, CITY, TOWNSHIP, VILLAGE, INTERCOUNTY, INTERCITY,
- 24 OR REGIONAL GOVERNING BODY; A COUNCIL, SCHOOL DISTRICT, SPECIAL
- 25 DISTRICT, OR MUNICIPAL CORPORATION; OR A BOARD, DEPARTMENT,
- 26 COMMISSION, OR COUNCIL OR AN AGENCY OF A BOARD, DEPARTMENT,
- 27 COMMISSION, OR COUNCIL.

- 1 (D) ANY OTHER BODY THAT IS CREATED BY STATE OR LOCAL AUTHORITY
- 2 OR IS PRIMARILY FUNDED BY OR THROUGH STATE OR LOCAL AUTHORITY, IF
- 3 THE BODY EXERCISES GOVERNMENTAL OR PROPRIETARY AUTHORITY OR
- 4 PERFORMS A GOVERNMENTAL OR PROPRIETARY FUNCTION.
- 5 Enacting section 1. This amendatory act takes effect 90 days
- 6 after the date it is enacted into law.
