A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 43502 and 43520 (MCL 324.43502 and 324.43520), as amended by 2013 PA 108.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 43502. (1) "Accompany" means to go along with another person—INDIVIDUAL under circumstances that allow one to come to the immediate aid of the other person—INDIVIDUAL and while staying within a distance from the person—OTHER INDIVIDUAL that permits uninterrupted, unaided visual and auditory communication.

- Sec. 43520. (1) Subject to other requirements of this part,

The person selling a hunting license 8 shall record as specified by the department the form of proof of 9 the previous hunting experience or certification of completion of 10 11 hunter safety training presented by the applicant. This subsection 12 does not apply to the issuance of an apprentice license. An apprentice license or the equivalent does not satisfy the 13 14 requirements of this subsection concerning proof of previous hunting experience. 15 (3) An individual who does not meet the requirements of 16 17 subsection (2) may obtain an apprentice license for the same price 18 as the corresponding regular license that the individual would 19 otherwise be qualified to obtain. An individual 17 years old or 20 older shall not hunt game under an apprentice license unless another individual at least 21 years old who possesses a license, 21 22 other than an apprentice license, to hunt that game accompanies 23 that apprentice licensee and does not accompany more than 1 other 24 apprentice licensee. For the purposes of this subsection and section 43517(1)(b), an individual shall not go along with more 25 26 than 2 apprentice licensees of any age for the purpose of 27 accompanying those apprentice licensees while those apprentice

1 licensees are hunting. If an individual has represented to an apprentice licensee or, if the apprentice licensee is a minor 2 child, to the apprentice licensee's parent or legal quardian that 3 4 the individual would accompany the apprentice licensee for the purposes of this subsection, the individual shall not go along with 5 6 the apprentice licensee while the apprentice licensee is hunting unless the individual actually accompanies the apprentice licensee 7 and possesses a license, other than an apprentice license, to hunt 8 the same game as the apprentice licensee. An individual is not 9 eligible to obtain a specific type of apprentice license, such as a 10 11 firearm deer license, an archery deer license, a combination deer 12 license, a small game license, or a turkey license, for more than 2 license years. An apprentice license shall be distinguished from a 13 license other than an apprentice license by a notation or other 14 15 means. (3) (4) Beginning March 1, 2014, an AN individual who does not 16 17 meet the requirements of subsection (2) may obtain an apprentice license for the same price as the corresponding regular license 18 19 that the individual would otherwise be qualified to obtain. An 20 individual 17 years old or older shall not hunt game under an apprentice license unless another individual at least 21 years old 21 22 who possesses a license, other than an apprentice license, to hunt 23 that game accompanies that apprentice licensee and does not 24 accompany more than 1 other apprentice licensee. For the purposes of this subsection and section 43517(1)(b), an individual shall not 25 go along with more than 2 apprentice licensees of any age for the 26 27 purpose of accompanying those apprentice licensees while those

- 14 (A) ANTLERLESS DEER LICENSES UNDER SECTION 43527A.
- 15 (B) A BEAR HUNTING LICENSE UNDER SECTION 43528.
- 16 (C) AN ELK HUNTING LICENSE UNDER SECTION 43529.
- 17 (7) By September 1, 2015 and every 4 years after that date,
- 18 the department shall submit a report to the standing committees of
- 19 the senate and house of representatives with primary responsibility
- 20 for conservation and outdoor recreation issues evaluating whether
- 21 the fee revenue received by the department from mentored youth
- 22 hunting licenses under subsection $\frac{(6)}{(5)}$ is adequate to administer
- 23 the mentored youth hunting program.
