A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1275.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1275. (1) NOT LATER THAN JANUARY 1, 2018, THE STATE BOARD
- 2 SHALL REVISE ITS MODEL LOCAL WELLNESS POLICY FOR LOCAL EDUCATION
- 3 AGENCIES TO INCLUDE A MODEL HEALTHY SCHOOL ENVIRONMENT POLICY,
- 4 FEATURING A PLAN AND SCHEDULE FOR TESTING THE WATER IN EVERY PUBLIC
- 5 SCHOOL FOR LEAD AND OTHER CONTAMINANTS, AS DETERMINED BY THE STATE
- 6 BOARD, AND A PLAN AND SCHEDULE FOR TESTING INDOOR AIR QUALITY IN
- 7 EVERY PUBLIC SCHOOL FOR CARBON DIOXIDE, PARTICULATE MATTER,
- 8 FORMALDEHYDE, VOCS, AND ANY OTHER SUBSTANCES AS DETERMINED BY THE
- 9 STATE BOARD. THE MODEL HEALTHY SCHOOL ENVIRONMENT POLICY CREATED
- 10 UNDER THIS SUBSECTION SHALL PROVIDE THAT THE DRINKING WATER AT
- 11 EVERY PUBLIC SCHOOL IS TESTED WITHIN 90 DAYS OF THE CREATION OF THE

- 1 MODEL HEALTHY SCHOOL ENVIRONMENT POLICY. THE MODEL HEALTHY SCHOOL
- 2 ENVIRONMENT POLICY SHALL INCLUDE A DESCRIPTION OF THE VARIOUS
- 3 SOURCES, CONTAMINANTS, OR FACTORS THAT COULD POTENTIALLY CONTRIBUTE
- 4 TO POOR INDOOR AIR OR WATER QUALITY AT A PUBLIC SCHOOL AND
- 5 GUIDELINES FOR A LOCAL EDUCATION AGENCY'S RESPONSE TO THE PRESENCE
- 6 OF THE VARIOUS SOURCES, CONTAMINANTS, AND OTHER FACTORS IN A PUBLIC
- 7 SCHOOL. THE STATE BOARD SHALL SPECIFICALLY EVALUATE COMMON CAUSES
- 8 OF CONTAMINATION OF INDOOR AIR AND DRINKING WATER, INCLUDING, BUT
- 9 NOT LIMITED TO, WATER PIPES, ON-SITE DISTRIBUTION SYSTEMS FOR WATER
- 10 AND AIR, HVAC MAINTENANCE, PAINTS AND COATINGS, AND CLEANING
- 11 PRODUCTS. THE STATE BOARD SHALL MAKE RECOMMENDATIONS FOR
- 12 IMPROVEMENTS BASED ON THE EVALUATION UNDER THIS SUBSECTION.
- 13 (2) NOT LATER THAN 1 YEAR AFTER THE CREATION OF THE MODEL
- 14 HEALTHY SCHOOL ENVIRONMENT POLICY UNDER SUBSECTION (1), THE
- 15 GOVERNING BOARD OF A LOCAL EDUCATION AGENCY SHALL SUBMIT TO THE
- 16 DEPARTMENT A REVISION OF ITS LOCAL WELLNESS POLICY THAT INCLUDES A
- 17 PLAN THAT IS CONSISTENT WITH THE STATE BOARD MODEL HEALTHY SCHOOL
- 18 ENVIRONMENT POLICY CREATED UNDER SUBSECTION (1) FOR TESTING THE
- 19 WATER AND AIR IN EVERY PUBLIC SCHOOL FOR THE CONTAMINANTS SPECIFIED
- 20 BY THE STATE BOARD.
- 21 (3) THE DEPARTMENT SHALL REQUIRE EACH LOCAL EDUCATION AGENCY
- 22 TO SUBMIT ITS LOCAL WELLNESS POLICY TO THE DEPARTMENT FOR REVIEW AT
- 23 LEAST EVERY 5 YEARS, OR MORE FREQUENTLY IF REQUIRED UNDER FEDERAL
- 24 LAW.
- 25 (4) NOT LATER THAN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS
- 26 SECTION, THE DEPARTMENT, IN CONJUNCTION WITH THE DEPARTMENT OF
- 27 ENVIRONMENTAL QUALITY, SHALL PROMULGATE RULES SETTING FORTH

- 1 REQUIREMENTS FOR ACTION TO BE TAKEN BY A LOCAL EDUCATION AGENCY
- 2 WHEN TESTING DISCLOSES CONTAMINATION ABOVE ACCEPTABLE LEVELS.
- 3 (5) A LOCAL EDUCATION AGENCY SHALL ENSURE THAT NOT LESS THAN
- 4 75% OF CLEANING PRODUCTS USED IN A PUBLIC SCHOOL ARE GREEN PRODUCT
- 5 CLEANING SUPPLIES AND MEET THE FOLLOWING:
- 6 (A) CLEANING CHEMICALS AND SKIN CARE PRODUCTS MUST CARRY 1 OR
- 7 MORE OF THE FOLLOWING CERTIFICATIONS:
- 8 (i) UNITED STATES ENVIRONMENTAL PROTECTION AGENCY'S SAFER
- 9 CHOICE.
- 10 (ii) GREEN SEAL.
- 11 (iii) GREEN GUARD.
- 12 (iv) ENVIRONMENTAL CHOICE.
- 13 (v) ANY OTHER CERTIFICATION DEEMED APPROPRIATE BY THE STATE
- 14 BOARD.
- 15 (B) PAPER PRODUCTS AND TRASH LINERS MUST CARRY 1 OR MORE OF
- 16 THE FOLLOWING CERTIFICATIONS OR GUIDELINES:
- 17 (i) FSC (FOREST STEWARDSHIP COUNCIL).
- 18 (ii) UNITED STATES ENVIRONMENTAL PROTECTION AGENCY'S
- 19 GUIDELINES FOR POSTCONSUMER RECYCLED CONTENT.
- 20 (iii) GREEN SEAL.
- 21 (iv) ENVIRONMENTAL CHOICE.
- 22 (v) ANY OTHER CERTIFICATION DEEMED APPROPRIATE BY THE STATE
- 23 BOARD.
- 24 (6) THE STATE BOARD SHALL COORDINATE WITH EACH LOCAL EDUCATION
- 25 AGENCY TO PROVIDE TECHNICAL ASSISTANCE DURING THE SCHOOL AIR AND
- 26 WATER QUALITY TESTING. THE STATE BOARD SHALL ALSO MONITOR THE
- 27 FINDINGS OF THE LOCAL EDUCATION AGENCY AND, NOT LATER THAN 6 MONTHS

- 1 AFTER THE TESTS ARE COMPLETED, GENERATE A REPORT OF THE FINDINGS
- 2 FOR REVIEW BY THE LEGISLATURE OF THIS STATE. THE REPORT SHALL DO AT
- 3 LEAST ALL OF THE FOLLOWING:
- 4 (A) EVALUATE THE RISKS FOUND ACROSS THE PUBLIC SCHOOLS TESTED.
- 5 (B) EVALUATE WHETHER ADDITIONAL FUNDS ARE NEEDED TO ENSURE
- 6 THAT ALL PUPILS IN THIS STATE ATTEND HEALTHY SCHOOLS.
- 7 (C) EVALUATE EXISTING MODELS AND FRAMEWORKS, INCLUDING, BUT
- 8 NOT LIMITED TO, EPA TOOLS FOR SCHOOLS, US DEPARTMENT OF EDUCATION
- 9 GREEN RIBBON SCHOOLS PROGRAM, AND US GREEN BUILDING COUNCIL'S LEED
- 10 FOR SCHOOLS.
- 11 (7) THE STATE BOARD SHALL CONSULT WITH THE DEPARTMENT OF
- 12 ENVIRONMENTAL QUALITY ON THE REVISION OF THE MODEL LOCAL WELLNESS
- 13 POLICY UNDER SUBSECTION (1).
- 14 (8) AS USED IN THIS SECTION:
- 15 (A) "LOCAL EDUCATION AGENCY" MEANS THAT TERM AS DEFINED IN 34
- 16 CFR 303.23.
- 17 (B) "GREEN PRODUCT CLEANING SUPPLIES" MEANS ENVIRONMENTALLY
- 18 PREFERABLE CLEANING AND MAINTENANCE PRODUCTS AND SUPPLIES INTENDED
- 19 FOR ROUTINE CLEANING AND CLEANING MAINTENANCE THAT PERFORM WELL AND
- 20 HAVE POSITIVE HEALTH AND ENVIRONMENTAL ATTRIBUTES, INCLUDING, BUT
- 21 NOT LIMITED TO, BIODEGRADABILITY, LOW TOXICITY, LOW VOLATILE
- 22 ORGANIC COMPOUND CONTENT, REDUCED PACKAGING, LOW LIFE-CYCLE ENERGY
- 23 USE, AND LESSER OR REDUCED EFFECTS ON HUMAN HEALTH AND THE
- 24 ENVIRONMENT WHEN COMPARED TO COMPETING PRODUCTS THAT SERVE THE SAME
- 25 PURPOSE.
- **26** Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.

- 1 Enacting section 2. This amendatory act does not take effect
- 2 unless Senate Bill No. ____ or House Bill No. 4979 (request no.
- 3 04182'17) of the 99th Legislature is enacted into law.
