HOUSE BILL No. 5017

September 27, 2017, Introduced by Rep. Lucido and referred to the Committee on Law and Justice.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411x.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411X. (1) A PERSON SHALL NOT CYBERBULLY ANOTHER PERSON.
- 2 (2) A PERSON WHO VIOLATES SUBSECTION (1) AND BY THAT VIOLATION
- 3 CAUSES THE VICTIM TO SUFFER FROM AN ASSAULT OR AN ASSAULT AND
- 4 BATTERY BY THE VIOLATOR OR ANY OTHER PERSON IS GUILTY OF A
 - MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR
 - A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 7 (3) A PERSON WHO VIOLATES SUBSECTION (1) AND BY THAT VIOLATION
- 8 CAUSES THE DEATH OF THE VICTIM, REGARDLESS OF WHETHER THE VIOLATOR
- 9 PHYSICALLY CAUSED THE DEATH OF THE VICTIM OR THE VICTIM'S DEATH WAS
- 10 DUE TO THE SUICIDE OF THE VICTIM AS A RESULT OF THE VIOLATION OF

- 14 (C) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 15 INTIMIDATE, FRIGHTEN, OR HARASS ANY OTHER PERSON OR TO CAUSE
- 16 EMOTIONAL DISTRESS.
- 17 (ii) POSTING A MESSAGE OR STATEMENT IN A PUBLIC MEDIA FORUM
- 18 ABOUT ANY OTHER PERSON IF BOTH OF THE FOLLOWING APPLY:
- 19 (A) THE PERSON MAKING THE POSTING INTENTIONALLY CONCEALS HIS

- 23 (B) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 24 INTIMIDATE, FRIGHTEN, OR HARASS ANY OTHER PERSON OR TO CAUSE
- 25 EMOTIONAL DISTRESS.
- 26 (iii) POSTING A MESSAGE OR STATEMENT IN A PUBLIC MEDIA FORUM
- 27 URGING, RECOMMENDING, OR SOLICITING ANOTHER PERSON TO INJURE OR

- 1 KILL HIMSELF OR HERSELF, OR URGING ANOTHER PERSON TO INJURE OR KILL
- 2 THE PERSON THE POSTING WAS MADE ABOUT, IF ANY OF THE FOLLOWING

- 4 (A) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 5 CAUSE THE OTHER PERSON TO INJURE OR KILL HIMSELF OR HERSELF OR IS
- 6 POSTED UNDER CIRCUMSTANCES OR IN SUCH A MANNER THAT A REASONABLE
- 7 PERSON WOULD KNOW THAT THE OTHER PERSON MAY INJURE OR KILL HIMSELF
- 8 OR HERSELF.
- 9 (B) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 10 CAUSE ANOTHER PERSON TO INJURE OR KILL THE PERSON ABOUT WHOM THE
- 11 POST WAS MADE OR IS POSTED UNDER CIRCUMSTANCES OR IN SUCH A MANNER
- 12 THAT A REASONABLE PERSON WOULD KNOW THAT ANOTHER PERSON MAY INJURE
- 13 OR KILL THE PERSON ABOUT WHOM THE POST WAS MADE.
- 14 (C) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 15 INTIMIDATE, FRIGHTEN, OR HARASS ANY OTHER PERSON OR TO CAUSE
- 16 EMOTIONAL DISTRESS.
- 17 (B) "PUBLIC MEDIA FORUM" MEANS THE INTERNET OR ANY OTHER
- 18 MEDIUM DESIGNED OR INTENDED TO BE USED TO CONVEY INFORMATION TO
- 19 OTHER INDIVIDUALS, REGARDLESS OF WHETHER A MEMBERSHIP OR PASSWORD
- 20 IS REQUIRED TO VIEW THE INFORMATION.
- 21 Enacting section 1. This amendatory act takes effect 90 days
- 22 after the date it is enacted into law.
