- (a) "Employer" means an individual or entity that permits an individual to work under an express or implied contract of hire, accepts applications for employment, or refers individuals for employment.
- (b) "Initial application for employment" means a paper or electronic application used to gather information about job applicants at a preliminary stage before any evaluation or

- 2 Sec. 5. An employer shall not make or use an initial
- 3 application for employment that elicits or attempts to elicit
