A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 1911 (MCL 324.1911), as added by 2010 PA 32, and by adding sections 1903b and 70306.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1903B. APPROPRIATIONS AND GRANTS FROM THE TRUST FUND FOR
- 2 PLAYGROUND EQUIPMENT SHALL PRIORITIZE HANDICAP-ACCESSIBLE
- 3 EQUIPMENT, SUCH AS RAMPED, GROUND-LEVEL PLAY FEATURES, UNIVERSALLY
- 4 ACCESSIBLE SWINGS, WHEELCHAIR-ACCESSIBLE TABLES, ADJUSTABLE
- 5 EQUIPMENT, AND TRANSFER PLATFORMS.
- Sec. 1911. (1) The local public recreation facilities fund is
- 7 created within the state treasury.

- 1 (2) The state treasurer may receive money or other assets from
- 2 any source for deposit into the local public recreation facilities

- 24 SHALL PRIORITIZE EQUIPMENT AS DESCRIBED IN SECTION 1903B.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
