8 **GENERAL SECTIONS**

9 Sec. 201. In accordance with the provisions of section 30 of
 10 article IX of the state constitution of 1963, total state spending
 11 from state resources in this appropriation act for the fiscal year
 12 ending September 30, 2018 is \$1,000,000.00 and state appropriations
 13 paid to local units of government are \$1,000,000.00.

14 Sec. 202. The appropriations made and expenditures authorized
 15 under this act and the departments, commissions, boards, offices,
 16 and programs for which appropriations are made under this act are
 17 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 18 to 18.1594.

19 **DEPARTMENT OF EDUCATION**

20 Sec. 301. From the funds appropriated in part 1 for the every
 21 child ready to read program, the department of education shall use
 22 the funds to create and operate the every child ready to read
 23 program to support early literacy development in this state.
