## 8 GENERAL SECTIONS

- 9 Sec. 201. In accordance with the provisions of section 30 of 10 article IX of the state constitution of 1963, total state spending 11 from state resources in this appropriation act for the fiscal year 12 ending September 30, 2018 is \$1,000,000.00 and state appropriations 13 paid to local units of government are \$1,000,000.00.
- Sec. 202. The appropriations made and expenditures authorized under this act and the departments, commissions, boards, offices, and programs for which appropriations are made under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

## 19 DEPARTMENT OF EDUCATION

Sec. 301. From the funds appropriated in part 1 for the every child ready to read program, the department of education shall use the funds to create and operate the every child ready to read program to support early literacy development in this state.
