THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the "seed potato act".
 - Sec. 2. As used in this act:

- (a) "Advisory committee" means the seed potato advisory committee created in section 6.
- (b) "Certified seed" means a class of seed that meets the requirements of 1959 PA 221, MCL 286.71 to 286.75, and the rules promulgated under that act.

- 1 (c) "Certifying authority" means the official seed-certifying
- 2 agency of this state or the authorized seed potato certifying
- 3 agency of another state, territory, or country.
- 4 (d) "Cultivar" means unique variety.
- (e) "Department" means the department of agriculture and ruraldevelopment.
- 7 (f) "Director" means the director of the department.
- 8 (g) "Distribute" means to offer for sale, sell, barter,
- 9 deliver, supply, furnish, or otherwise provide seed potatoes.
- 10 (h) "Field year" means the number of years a particular seed
- 11 lot has been grown in the field after greenhouse propagation.
- 12 (i) "Fund" means the seed potato fund created in section 10.
- 13 (j) "Hundredweight" means a unit of weight equal to 100

- 15 (k) "Person" means an individual, partnership, association,

- 17 (l) "Rule" means a rule promulgated pursuant to the
- 18 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to

- 20 (m) "Seed lot" means all the seed potatoes of the same variety
- 21 that are of a single class and specific seed source and are
- 22 harvested from a field or stored together in a specific storage
- 23 facility.
- 24 (n) "Seed potato" means the tuber that is used for the
- 25 reproduction of the potato.
- (o) "State national harmonization program" means the state
- 27 national harmonization program for seed potatoes developed by the

- 1 plant protection and quarantine program of the Animal and Plant
- 2 Health Inspection Service in the United States Department of
- 3 Agriculture.
- 4 Sec. 3. (1) Beginning January 1, 2021, a person who
- 5 distributes combined seed lots sufficient to plant 1 or more acres
- 6 in this state as determined by the director by rule must distribute
- 7 only certified seed.
- **8** (2) All seed lots of seed potatoes subject to subsection (1)
- 9 must at the time of distribution, be accompanied by all of the
- following documents:
- 11 (a) An official tag or bulk certificate indicating their
- 12 status as certified seed.
- 13 (b) A certificate of shipping point inspection.
- 14 (c) A North American plant health certificate issued by the
- 15 certifying authority for seed potatoes imported from outside of
- 16 this state.
- 17 (d) Any other documentation necessary to provide the
- 18 information required by subsection (3).
- 19 (3) The documents described in subsection (2) must provide the
- 20 following:
- 21 (a) A description of the grade of the seed potatoes.
- (b) The findings of field inspections and postharvest
- 23 inspections conducted on each seed lot of seed potatoes.
- 24 (c) The field year of the seed potatoes.
- 25 (d) Evidence that the seed potatoes were tagged and, if
- 26 imported from outside this state, packed and sealed under the
- 27 certification standards of the state, territory, or country in

- 1 which they were grown.
- 2 Sec. 4. (1) Beginning January 1, 2021, and except as otherwise
- 3 permitted under this section, seed potatoes in combined seed lots
- 4 that are sufficient to plant 1 or more acres as determined by the
- 5 director by rule may only be planted if the seed potatoes are
- 6 certified seed. Seed potatoes imported into this state must meet
- 7 the minimum standards in the state national harmonization program
- 8 and in any active applicable quarantine or rule.
- 9 (2) Beginning January 1, 2021, a potato grower may plant
- 10 uncertified potatoes if both of the following conditions are met:
- 11 (a) The potatoes were grown and stored as part of that
- 12 grower's farming operations.
- 13 (b) The uncertified potatoes are no more than 1 field year
- 14 from certified seed potatoes.
- 15 (3) Beginning January 1, 2021, in any year that there is an
- 16 insufficient volume of any cultivar of certified seed potatoes and
- 17 seed potatoes meeting the requirements of this section, potato
- 18 growers may apply to the advisory committee for permission to plant
- 19 uncertified seed potatoes. Upon recommendation from the advisory
- 20 committee, the director may grant applying growers permission to
- 21 plant uncertified seed potatoes for only that growing season.
- 22 Sec. 5. (1) Beginning January 1, 2021, each person growing
- 23 potatoes in this state in combined seed lots of 1 acre or greater
- 24 shall notify the director of this fact by January 1 of each year
- 25 and shall keep and maintain records as described in this section.
- 26 The records must contain the information required for an
- 27 independent records review conducted under subsection (2). Growers

- 1 shall maintain the records for a period of at least 2 years at the
- 2 grower's business address.
- 3 (2) Beginning January 1, 2021, the director shall select a
- 4 qualified department employee or independent auditor to perform a
- 5 records review on at least 10% of potato growers subject to this
- 6 act once every seed potato crop cycle. The director shall determine
- 7 a method for the annual random selection of growers.
- 8 (3) A records review performed under this section must verify
- 9 records that trace back the grower's potatoes, including records
- 10 that evidence both of the following:
- 11 (a) Acreage planted by cultivar.
- 12 (b) Hundredweight and source of the seed potatoes used to
- 13 plant the acreage, with verifiable documents related to the
- 14 following:
- 15 (i) For seed potatoes purchased, the documents described in
- 16 section 3.
- (ii) For seed potatoes planted as provided under section 4,
- 18 the testing history and seed potatoes used to replant the grower's
- 19 own operations.
- 20 (4) If the independent auditor who conducted the records
- 21 review believes that a violation of this section has occurred, he
- 22 or she shall notify the director within 5 business days. The
- 23 director must then investigate the alleged violation according to
- 24 section 8.
- 25 Sec. 6. (1) The seed potato advisory committee is created.
- 26 (2) The advisory committee shall consist of 5 members
- 27 appointed by the director as follows:

- 1 (a) Two commercial potato growers who do not grow seed
- 2 potatoes.
- 3 (b) The current chair of the Michigan Seed Potato Association.
- 4 (c) One person employed by Michigan State University.
- 5 (d) One person employed by the department.
- **6** (3) Whenever possible, the advisory committee members
- ${f 7}$ appointed under subsection (2)(c) and (d) must have knowledge of or
- 8 experience with seed potatoes.
- 9 (4) Except as provided in subsection (5), members appointed to
- 10 the advisory committee shall serve for terms of 3 years. Members
- 11 may be appointed for an unlimited number of terms, except that a
- 12 member appointed under subsection (2)(a) may not serve more than 2
- 13 terms consecutively.
- 14 (5) In the event of a vacancy on the advisory committee prior
- 15 to the completion of a member's full term, the director shall
- 16 appoint a person to complete the remainder of that term. The person
- 17 appointed under this subsection must represent the same group as
- 18 the member he or she is replacing, as provided in subsection (2).
- 19 (6) The members of the advisory committee will receive no
- 20 compensation or reimbursement for any expenses incurred in the
- 21 exercise of their duties.
- 22 (7) The advisory committee shall advise the director in
- 23 establishing rules under this act, assist in the determination of
- 24 availability of seed potatoes, recommend whether to grant
- 25 permission to plant uncertified seed potatoes, recommend
- 26 independent auditors to perform records reviews under section 5,
- 27 and consult with the director regarding the administration and

- 1 enforcement of this act.
- 2 Sec. 7. In addition to any other duties provided in this act,
- 3 the director shall do both of the following:
- 4 (a) Administer and enforce this act.
- 5 (b) Promulgate rules necessary for the administration and
- 6 enforcement of this act, including rules that do all of the
- 7 following:
- 8 (i) Establish requirements for compliance.
- 9 (ii) Allow for the random selection of 10% of potato growers
- 10 subject to the annual records review required under section 5(2).
- 11 (iii) Establish methods for determining whether there are
- 12 unacceptable levels of disease beyond the level of tolerance
- 13 established under 1959 PA 221, MCL 286.71 to 286.75, and the rules
- 14 promulgated under that act for seed potatoes planted under section
- **15** 4 (3).
- (iv) Set a schedule of fees for services performed by the
- 17 department.
- 18 Sec. 8. (1) Beginning January 1, 2021, the director, upon the
- 19 director's own motion or upon the recommendation of an independent
- 20 auditor under section 5(2), may make an investigation necessary to
- 21 determine compliance with this act.
- 22 (2) For an inspection under subsection (1), the director must
- 23 have free and unimpeded access during regular business hours,
- 24 either upon consent of the owner or upon obtaining an
- 25 administrative search warrant, to inspect any records required to
- 26 be kept pursuant to this act.
- 27 (3) The director may make copies of any records inspected

- 1 under subsection (2).
- 2 (4) The director may do 1 or more of the following:
- 3 (a) Administer oaths.
- 4 (b) Take statements.
- 5 (c) Issue subpoenas to compel the attendance of witnesses.
- 6 (d) Issue subpoenas for the production of any books,
- 7 memoranda, papers, or other documents, articles, or instruments.
- **8** (5) Upon failure or refusal of any person to obey a subpoena
- 9 issued under subsection (4), the director may petition the district
- 10 court to enter an order compelling that person to comply with the
- 11 subpoena.
- 12 (6) Failure to obey an order of the court entered under
- 13 subsection (5) may be punishable as contempt of court.
- 14 (7) A complaint made to the director and the results of the
- 15 director's investigations must be closed to public inspection
- 16 unless disclosed pursuant to court order, during the investigatory
- 17 period and until the complaint is dismissed or the notice of
- 18 hearing and charges are served.
- 19 Sec. 9. (1) Beginning January 1, 2021, and except as otherwise
- 20 provided in this section, the director may impose an administrative
- 21 fine on any person that violates this act or a rule promulgated
- 22 under this act. An administrative fine imposed under this section
- 23 may not exceed \$2,500.00 per violation.
- 24 (2) Beginning January 1, 2021, a person who plants or
- 25 distributes potatoes in violation of this act or a rule promulgated
- 26 under this act is subject to an administrative fine, as determined
- 27 by the director. An administrative fine imposed by the director

- 1 under this subsection must be at least \$20.00 per acre but may not
- 2 exceed \$100.00 per acre per violation.
- **3** (3) Beginning January 1, 2021, a person who fails to maintain
- 4 complete and accurate records under section 5 or a rule promulgated
- 5 under this act regarding records or fees is subject to an
- 6 administrative fine, as determined by the director. An
- 7 administrative fine imposed by the director under this subsection
- **8** must be at least \$500.00 but may not exceed \$1,000.00.
- 9 (4) An administrative fine may not be imposed under this
- 10 section unless the person charged with the violation is given
- 11 notice and an opportunity for a hearing held under the
- 12 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- **13** 24.328.
- 14 (5) If the director is unable to collect an administrative
- 15 fine or if any person fails to pay all or a set portion of an
- 16 administrative fine, the director may bring suit in any court of
- 17 competent jurisdiction to recover the fine plus costs and attorney
- 18 fees.
- 19 (6) Money collected from any administrative fine imposed under
- 20 this section must be paid to the state treasurer, who shall credit
- 21 the same to the fund.
- Sec. 10. (1) Beginning January 1, 2021, the seed potato fund
- 23 is created within the state treasury.
- 24 (2) The state treasurer may receive money or other assets from
- 25 any source for deposit into the fund, including all fees and
- 26 administrative fines collected under this act. The state treasurer
- 27 shall direct the investment of the fund. The state treasurer shall

- 1 credit to the fund interest and earnings from fund investments.
- 2 (3) Money in the fund at the close of the fiscal year must
- 3 remain in the fund and may not lapse to the general fund.
- 4 (4) The department shall be the administrator of the fund for
- 5 auditing purposes.
- **6** (5) The department shall expend money from the fund, upon
- 7 appropriation, only to implement this act.
- 8 Sec. 11. This act is repealed effective January 1, 2023.
- 9 Enacting section 1. This act takes effect 90 days after the
- 10 date it is enacted into law.
