## **HOUSE BILL No. 5240**

November 9, 2017, Introduced by Reps. Marino, Wentworth, Inman and Kahle and referred to the Committee on Transportation and Infrastructure.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803e (MCL 257.803e), as amended by 2011 PA 46.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 803e. (1) A person who has been a prisoner of war or a person whose spouse has been a prisoner of war may make application APPLY to the secretary of state for a special registration plate that shall be inscribed with special identification numbers preceded by the letters "EX-POW" and shall have the words "exprisoner of war" inscribed beneath the registration number.

(2) A person who was a member of the armed services during World War I may make application APPLY to the secretary of state for a special registration plate , that shall be inscribed with special identification numbers preceded by the letters "WWI" and

- **3** (3) A person who was a member of the armed services during
- 4 1941, stationed at a United States military or naval establishment
- 5 at Pearl Harbor in the Hawaiian islands, and who survived the
- 6 attack by Japan on Pearl Harbor on December 7, 1941 may make
- 7 application APPLY to the secretary of state for a special
- 8 registration plate , that shall be inscribed with special
- 9 identification numbers and shall have the words "Pearl Harbor
- 10 survivor" inscribed beneath the registration number.
- 11 (4) A person who is a recipient of the purple heart PURPLE
- 12 HEART medal may make application APPLY to the secretary of state
- 13 for a special registration plate that shall be inscribed with
- 14 special identification numbers and shall have the words "combat
- 15 wounded veteran" inscribed beneath the registration number. In
- 16 addition, the special registration plate described under this
- 17 subsection shall be inscribed with a vignette of the official
- 18 purple heart PURPLE HEART medal.
- 19 (5) Application for a special registration plate shall be on a
- 20 form prescribed by the secretary of state, and shall be accompanied
- 21 by any proof of the applicant having been a prisoner of war, World
- 22 War I veteran, Pearl Harbor survivor, OR recipient of the purple
- 23 heart PURPLE HEART medal that the secretary of state may require.
- 24 Application for a "Gold Star Family" special registration plate
- 25 described in subsection (9) shall be on a form prescribed by the
- 26 secretary of state and shall be accompanied by any proof of the
- 27 applicant having been a gold star family member that the secretary

- 1 of state may require. The application for a special registration
- 2 plate shall also be accompanied with payment of a \$5.00 service
- 3 fee.
- 4 (6) Upon proper application and payment of the \$5.00 service
- 5 fee, the secretary of state shall issue 1 or more special
- 6 registration plates for each applicant for use on a passenger
- 7 vehicle. A person who is disabled who makes application for a
- 8 special registration plate under this section and who makes payment
- 9 of the \$5.00 service fee shall be issued a tab for persons with
- 10 disabilities as provided in section 803f for his or her special
- 11 registration plate. The secretary of state shall require the same
- 12 proof that the applicant is a disabled person as is required for
- 13 issuance of a permanent windshield placard under section 675. One
- 14 person in any household is entitled to 1 special registration plate
- 15 issued under subsection (1) OR (4) that is exempt from payment of
- 16 the tax provided in section 801. The person who is issued an
- 17 additional special registration plate under subsection (1) OR (4)
- 18 shall be assessed the applicable tax provided for in section 801. A
- 19 person issued 1 or more special registration plates under
- 20 subsection (2), (3),  $\frac{(4)}{}$  or (9) shall be assessed the applicable
- 21 tax provided in section 801.
- 22 (7) The use of a special registration plate on a vehicle other
- 23 than the vehicle for which the plate is issued, or by a person who
- 24 does not qualify under this section, is a misdemeanor.
- 25 (8) The special registration plate issued under this section
- 26 expires on the birthday of the vehicle owner in a year in which new
- 27 plates are issued by the secretary of state. Application for

- 1 renewal of the special registration plate shall be accompanied by a
- 2 \$5.00 service fee. The applicant is not required to furnish the
- 3 proof provided in subsection (5).
- 4 (9) A gold star family member may make application APPLY to
- 5 the secretary of state for a special registration plate that shall
- 6 be-inscribed with special identification numbers preceded by a gold
- 7 star and shall have the words "Gold Star Family" inscribed beneath
- 8 the registration number.
- 9 (10) As used in this section, "gold star family member" means
- 10 a person who has had an immediate family member die while serving
- 11 in the United States armed forces ARMED FORCES or in forces
- 12 incorporated as part of the United States armed forces ARMED FORCES
- 13 if the immediate family member meets any of the eligibility
- 14 criteria specified in 10 USC 1126(a)(1) to (3) for a gold star
- 15 lapel button.
- 16 Enacting section 1. This amendatory act takes effect 90 days
- 17 after the date it is enacted into law.
