

HOUSE BILL No. 5340

December 12, 2017, Introduced by Rep. Yaroach and referred to the Committee on Local Government.

A bill to amend 1966 PA 293, entitled

"An act to provide for the establishment of charter counties; to provide for the election of charter commissioners; to prescribe their powers and duties; to prohibit certain acts of a county board of commissioners after the approval of the election of a charter commission; to prescribe the mandatory and permissive provisions of a charter; to provide for the exercise by a charter county of certain powers whether or not authorized by its charter; and to prescribe penalties and provide remedies,"

by amending section 1a (MCL 45.501a), as added by 1988 PA 195.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1a. Notwithstanding any provision of this act, if an
2 emergency ~~financial manager~~ **OR A FINANCIAL MANAGEMENT TEAM** has been

16 Enacting section 1. This amendatory act takes effect 90 days
17 after the date it is enacted into law.

18 Enacting section 2. This amendatory act does not take effect
19 unless Senate Bill No. ____ or House Bill No. 5337 (request no.
20 03826'17) of the 99th Legislature is enacted into law.
