## **HOUSE BILL No. 5414**

January 16, 2018, Introduced by Reps. Hoitenga, Sheppard, Lucido, Rendon, Bizon, LaFave, Chirkun, Dianda, Hornberger, Phelps, Alexander, Johnson, Lower, Cole, VanSingel, Leutheuser, Hernandez and Glenn and referred to the Committee on Judiciary.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending sections 5b, 5c, 5d, 5e, and 5l (MCL 28.425b, 28.425c, 28.425d, 28.425e, and 28.425l), sections 5b and 5l as amended by 2017 PA 95 and sections 5c, 5d, and 5e as amended by 2015 PA 3; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5b. (1) To obtain a **STANDARD OR LIFETIME** license to carry a concealed pistol, an individual shall apply to the county clerk

- 1 in the county in which the individual resides. The applicant shall
- 2 file the application with the county clerk in the county in which
- 3 the applicant resides during the county clerk's normal business
- 4 hours. The application must be on a form provided by the director
- 5 of the department of state police and allow the applicant to
- 6 designate whether the applicant seeks an emergency license, A
- 7 STANDARD LICENSE, OR A LIFETIME LICENSE. The applicant shall sign
- 8 the application under oath. The county clerk or his or her
- 9 representative shall administer the oath. An application under this
- 10 subsection is not considered complete until an applicant submits
- 11 all of the required information and fees and has fingerprints taken
- 12 under subsection (9). An application under this subsection is
- 13 considered withdrawn if an applicant does not have fingerprints
- 14 taken under subsection (9) within 45 days of the date an
- 15 application is filed under this subsection. A completed application
- 16 and all receipts issued under this section expire 1 year from the
- 17 date of application. The county clerk shall issue the applicant a
- 18 receipt for his or her application at the time the application is
- 19 submitted containing the name of the applicant, the applicant's
- 20 state-issued driver license or personal identification card number,
- 21 the date and time the receipt is issued, the amount paid, the name
- 22 of the county in which the receipt is issued, an impression of the
- 23 county seal, and the statement, "This receipt was issued for the
- 24 purpose of applying for a concealed pistol license and for
- 25 obtaining fingerprints related to that application. This receipt
- 26 does not authorize an individual to carry a concealed pistol in
- 27 this state.". The application must contain all of the following:

- 1 (a) The applicant's legal name, date of birth, the address of
- 2 his or her primary residence, and his or her state-issued driver
- 3 license or personal identification card number.
- 4 (b) A statement by the applicant that the applicant meets the
- 5 criteria for a license under this act to carry a concealed pistol.
- 6 (c) A statement by the applicant authorizing the department of
- 7 state police to access any record needed to perform the
- **8** verification in subsection (6).
- 9 (d) A statement by the applicant regarding whether he or she
- 10 has a history of mental illness that would disqualify him or her
- 11 under subsection (7)(j) to (l) from receiving a license to carry a
- 12 concealed pistol.
- 13 (e) A statement by the applicant regarding whether he or she
- 14 has ever been convicted in this state or elsewhere for any of the
- 15 following:
- 16 (i) Any felony.
- 17 (ii) A misdemeanor listed under subsection (7) (h) if the
- 18 applicant was convicted of that misdemeanor in the 8 years
- 19 immediately preceding the date of the application, or a misdemeanor
- 20 listed under subsection (7)(i) if the applicant was convicted of
- 21 that misdemeanor in the 3 years immediately preceding the date of
- 22 the application.
- 23 (f) A statement by the applicant whether he or she has been
- 24 dishonorably discharged from the United States Armed Forces.
- 25 (g) If an applicant does not have a digitized photograph on
- 26 file with the secretary of state, a passport-quality photograph of
- 27 the applicant provided by the applicant at the time of application.

- 1 (h) A certificate stating that the applicant has completed the2 training course prescribed by this act.
- 3 (2) The county clerk shall not require the applicant to submit
- 4 any additional forms, documents, letters, or other evidence of
- 5 eligibility for obtaining a license to carry a concealed pistol
- 6 except as set forth in subsection (1) or as otherwise provided for
- 7 in this act. The application form must contain a conspicuous
- 8 warning that the application is executed under oath and that
- 9 intentionally making a material false statement on the application
- 10 is a felony punishable by imprisonment for not more than 4 years or
- 11 a fine of not more than \$2,500.00, or both.
- 12 (3) An individual who intentionally makes a material false
- 13 statement on an application under subsection (1) is guilty of a
- 14 felony punishable by imprisonment for not more than 4 years or a
- 15 fine of not more than \$2,500.00, or both.
- 16 (4) The county clerk shall retain a copy of each application
- 17 for a license to carry a concealed pistol as an official record.
- 18 One year after the expiration of a concealed pistol license, the
- 19 county clerk may destroy the record and a name index of the record
- 20 shall MUST be maintained in the database created in section 5e.
- 21 (5) Each applicant shall pay a nonrefundable application and
- 22 licensing fee of \$100.00 FOR A STANDARD LICENSE OR \$150.00 FOR A
- 23 LIFETIME LICENSE, by any method of payment accepted by that county
- 24 for payments of other fees and penalties. Except as provided in
- 25 subsection (9), no other charge, fee, cost, or assessment,
- 26 including any local charge, fee, cost, or assessment, is required
- 27 of the applicant except as specifically authorized in this act. The

- 1 applicant shall pay the application and licensing fee to the
- 2 county. The county treasurer shall deposit \$26.00 of each
- 3 application and licensing fee collected under this section in the
- 4 concealed pistol licensing fund of that county created in section
- 5 5x. The county treasurer shall forward the balance remaining to the
- 6 state treasurer. The state treasurer shall deposit the balance of
- 7 the fee in the general fund to the credit of the department of
- 8 state police. The department of state police shall use the money
- 9 received under this act to process the fingerprints and to
- 10 reimburse the Federal Bureau of Investigation for the costs
- 11 associated with processing fingerprints submitted under this act.
- 12 The balance of the money received under this act must be credited
- 13 to the department of state police.
- 14 (6) The department of state police shall verify the
- 15 requirements of subsection (7) (d), (e), (f), (h), (i), (j), (k),
- 16 and (m) through the law enforcement information network and the
- 17 national instant criminal background check system and shall report
- 18 to the county clerk all statutory disqualifications, if any, under
- 19 this act that apply to an applicant.
- 20 (7) The county clerk shall issue and shall—send by first-class
- 21 mail a license to an applicant to carry a concealed pistol within
- 22 the period required under this act if the county clerk determines
- 23 that all of the following circumstances exist:
- 24 (a) The applicant is 21 years of age or older.
- 25 (b) The applicant is a citizen of the United States or is an
- 26 alien lawfully admitted into the United States, is a legal resident
- 27 of this state, and has resided in this state for not less than the

- 1 6 months immediately preceding the date of application. The county
- 2 clerk shall waive the 6-month residency requirement for an
- 3 emergency license under section 5a(4) if the applicant is a
- 4 petitioner for a personal protection order issued under section
- 5 2950 or 2950a of the revised judicature act of 1961, 1961 PA 236,
- 6 MCL 600.2950 and 600.2950a, or if the county sheriff determines
- 7 that there is clear and convincing evidence to believe that the
- 8 safety of the applicant or the safety of a member of the
- 9 applicant's family or household is endangered by the applicant's
- 10 inability to immediately obtain a license to carry a concealed
- 11 pistol. If the applicant holds a valid concealed pistol license
- 12 issued by another state at the time the applicant's residency in
- 13 this state is established, the county clerk shall waive the 6-month
- 14 residency requirement and the applicant may apply for a concealed
- 15 pistol license at the time the applicant's residency in this state
- 16 is established. For the purposes of this section, an individual is
- 17 considered a legal resident of this state if any of the following
- 18 apply:
- 19 (i) The individual has a valid, lawfully obtained driver
- 20 license issued under the Michigan vehicle code, 1949 PA 300, MCL
- 21 257.1 to 257.923, or official state personal identification card
- 22 issued under 1972 PA 222, MCL 28.291 to 28.300.
- 23 (ii) The individual is lawfully registered to vote in this
- 24 state.
- 25 (iii) The individual is on active duty status with the United
- 26 States Armed Forces and is stationed outside of this state, but the
- 27 individual's home of record is in this state.

- 1 (iv) The individual is on active duty status with the United
- 2 States Armed Forces and is permanently stationed in this state, but
- 3 the individual's home of record is in another state.
- 4 (c) The applicant has knowledge and has had training in the
- 5 safe use and handling of a pistol by the successful completion of a
- 6 pistol safety training course or class that meets the requirements
- 7 of section 5j. FOR AN APPLICANT APPLYING FOR A LIFETIME LICENSE, A
- 8 COPY OF A VALID STANDARD LICENSE OR A STANDARD LICENSE THAT EXPIRED
- 9 NOT MORE THAN 1 YEAR BEFORE APPLYING FOR THE LIFETIME LICENSE IS
- 10 PROOF OF COMPLIANCE WITH SECTION 5J.
- 11 (d) Based solely on the report received from the department of
- 12 state police under subsection (6), the applicant is not the subject
- 13 of an order or disposition under any of the following:
- 14 (i) Section 464a of the mental health code, 1974 PA 258, MCL
- **15** 330.1464a.
- (ii) Section 5107 of the estates and protected individuals
- 17 code, 1998 PA 386, MCL 700.5107.
- 18 (iii) Sections 2950 and 2950a of the revised judicature act of
- 19 1961, 1961 PA 236, MCL 600.2950 and 600.2950a.
- 20 (iv) Section 6b of chapter V of the code of criminal
- 21 procedure, 1927 PA 175, MCL 765.6b, if the order has a condition
- 22 imposed under section 6b(3) of chapter V of the code of criminal

- (e) Based solely on the report received from the department of

- 2 carrying, shipping, receiving, or distributing a firearm under
- 3 section 224f of the Michigan penal code, 1931 PA 328, MCL 750.224f.
- 4 (f) Based solely on the report received from the department of
- 5 state police under subsection (6), the applicant has never been
- 6 convicted of a felony in this state or elsewhere, and a felony
- 7 charge against the applicant is not pending in this state or
- 8 elsewhere at the time he or she applies for a license described in
- 9 this section.
- 10 (g) The applicant has not been dishonorably discharged from
- 11 the United States Armed Forces.
- 12 (h) Based solely on the report received from the department of
- 13 state police under subsection (6), the applicant has not been
- 14 convicted of a misdemeanor violation of any of the following in the
- 15 8 years immediately preceding the date of application and a charge
- 16 for a misdemeanor violation of any of the following is not pending
- 17 against the applicant in this state or elsewhere at the time he or
- 18 she applies for a license described in this section:
- (i) Section 617a (failing to stop when involved in a personal
- 20 injury accident), section 625 as punishable under subsection (9)(b)
- 21 of that section (operating while intoxicated, second offense),
- 22 section 625m as punishable under subsection (4) of that section

- 13 insanity.
- 14 (k) Based solely on the report received from the department of
- 15 state police under subsection (6), the applicant is not currently
- 16 and has never been subject to an order of involuntary commitment in
- 17 an inpatient or outpatient setting due to mental illness.
- (l) The applicant has filed a statement under subsection
- 19 (1) (d) that the applicant does not have a diagnosis of mental
- 20 illness that includes an assessment that the individual presents a
- 21 danger to himself or herself or to another at the time the
- 22 application is made, regardless of whether he or she is receiving
- 23 treatment for that illness.
- 24 (m) Based solely on the report received from the department of
- 25 state police under subsection (6), the applicant is not under a
- 26 court order of legal incapacity in this state or elsewhere.
- (n) The applicant has a valid state-issued driver license or

- 1 personal identification card.
- 2 (8) Upon entry of a court order or conviction of 1 of the
- 3 enumerated prohibitions for using, transporting, selling,
- 4 purchasing, carrying, shipping, receiving, or distributing a
- 5 firearm in this section the department of state police shall
- 6 immediately enter the order or conviction into the law enforcement
- 7 information network. For purposes of this act, information of the
- 8 court order or conviction must not be removed from the law
- 9 enforcement information network, but may be moved to a separate
- 10 file intended for the use of the department of state police, the
- 11 courts, and other government entities as necessary and exclusively
- 12 to determine eligibility to be licensed under this act.
- 13 (9) An individual, after submitting an application and paying
- 14 the fee prescribed under subsection (5), shall request that
- 15 classifiable fingerprints be taken by a county clerk, the
- 16 department of state police, a county sheriff, a local police
- 17 agency, or other entity, if the county clerk, department of state
- 18 police, county sheriff, local police agency, or other entity
- 19 provides fingerprinting capability for the purposes of this act. An
- 20 individual who has had classifiable fingerprints taken under
- 21 section 5a(4) does not need additional fingerprints taken under
- 22 this subsection. AN INDIVIDUAL APPLYING FOR A LIFETIME LICENSE
- 23 WHOSE FINGERPRINTS ARE ON FILE FROM OBTAINING A STANDARD LICENSE
- 24 DOES NOT NEED ADDITIONAL FINGERPRINTS TAKEN UNDER THIS SUBSECTION.
- 25 If the individual requests that classifiable fingerprints be taken
- 26 by the county clerk, department of state police, county sheriff, a
- 27 local police agency, or other entity, the individual shall also pay

- 1 a fee of \$15.00 by any method of payment accepted for payments of
- 2 other fees and penalties. A county clerk shall deposit any fee it
- 3 accepts under this subsection in the concealed pistol licensing
- 4 fund of that county created in section 5x. The county clerk,
- 5 department of state police, county sheriff, local police agency, or
- 6 other entity shall take the fingerprints within 5 business days
- 7 after the request. County clerks, the department of state police,
- 8 county sheriffs, local police agencies, and other entities shall
- 9 provide reasonable access to fingerprinting services during normal
- 10 business hours as is necessary to comply with the requirements of
- 11 this act if the county clerk, department of state police, county
- 12 sheriff, local police agency, or other entity provides
- 13 fingerprinting capability for the purposes of this act. The entity
- 14 providing fingerprinting services shall issue the individual a
- 15 receipt at the time his or her fingerprints are taken. The county
- 16 clerk, department of state police, county sheriff, local police
- 17 agency, or other entity shall not provide a receipt under this
- 18 subsection unless the individual requesting the fingerprints
- 19 provides an application receipt received under subsection (1). A
- 20 receipt under this subsection must contain all of the following:
- 21 (a) The name of the individual.
- (b) The date and time the receipt is issued.
- (c) The amount paid.
- 24 (d) The name of the entity providing the fingerprint services.
- 25 (e) The individual's state-issued driver license or personal
- 26 identification card number.
- 27 (f) The statement "This receipt was issued for the purpose of

1 applying for a concealed pistol license. As provided in section 5b 2 of 1927 PA 372, MCL 28.425b, if a license or notice of statutory disqualification is not issued within 45 days after the date this 3 4 receipt was issued, this receipt shall serve as a concealed pistol 5 license for the individual named in the receipt when carried with an official state-issued driver license or personal identification card. The receipt is valid as a license until a license or notice 7 of statutory disqualification is issued by the county clerk. This 8 receipt does not exempt the individual named in the receipt from 9 complying with all applicable laws for the purchase of firearms.". 10 11 (10) The fingerprints must be taken, under subsection (9), in a manner prescribed by the department of state police. The county 12 clerk, county sheriff, local police agency, or other entity shall 13 14 immediately forward the fingerprints taken by that entity to the department of state police for comparison with fingerprints already 15 on file with the department of state police. The department of 16 17 state police shall immediately forward the fingerprints to the Federal Bureau of Investigation. Within 5 business days after 18 19 completing the verification under subsection (6), the department 20 shall send the county clerk a list of an individual's statutory 21 disqualifications under this act. Except as provided in section 22 5a(4), the county clerk shall not issue a concealed pistol license 23 until he or she receives the report of statutory disqualifications prescribed in this subsection. If an individual's fingerprints are 24 25 not classifiable, the department of state police shall, at no 26 charge, take the individual's fingerprints again or provide for the 27 comparisons under this subsection to be conducted through

- 1 alternative means. The county clerk shall not issue a notice of
- 2 statutory disqualification because an individual's fingerprints are
- 3 not classifiable by the Federal Bureau of Investigation.
- 4 (11) The county clerk shall send by first-class mail a notice
- 5 of statutory disqualification for a license under this act to an
- 6 individual if the individual is not qualified under subsection (7)
- 7 to receive that license.
- 8 (12) A license to carry a concealed pistol that is issued
- 9 based upon an application that contains a material false statement
- 10 is void from the date the license is issued.
- 11 (13) Subject to subsection (10), the department of state
- 12 police shall complete the verification required under subsection
- 13 (6) and the county clerk shall issue a license or a notice of
- 14 statutory disqualification within 45 days after the date the
- 15 individual has classifiable fingerprints taken under subsection
- 16 (9). The county clerk shall include an indication on the license if
- 17 an individual is exempt from the prohibitions against carrying a
- 18 concealed pistol on premises described in section 50 if the
- 19 applicant provides acceptable proof that he or she qualifies for
- 20 that exemption. If the county clerk receives notice from a county
- 21 sheriff or chief law enforcement officer that a licensee is no
- 22 longer a member of a sheriff's posse, an auxiliary officer, or a
- 23 reserve officer, the county clerk shall notify the licensee that he
- 24 or she shall surrender the concealed pistol license indicating that
- 25 the individual is exempt from the prohibitions against carrying a
- 26 concealed pistol on premises described in section 5o. The licensee
- 27 shall, within 30 days after receiving notice from the county clerk,

- 1 surrender the license indicating that the individual is exempt from
- 2 the prohibitions against carrying a concealed pistol on premises
- 3 described in section 50 and obtain a replacement license after
- 4 paying the fee required under subsection (15). If the county clerk
- 5 issues a notice of statutory disqualification, the county clerk
- 6 shall within 5 business days do all of the following:
- 7 (a) Inform the individual in writing of the reasons for the
- 8 denial or disqualification. Information under this subdivision
- 9 shall MUST include all of the following:
- 10 (i) A statement of each statutory disqualification identified.
- 11 (ii) The source of the record for each statutory
- 12 disqualification identified.
- 13 (iii) The contact information for the source of the record for
- 14 each statutory disqualification identified.
- 15 (b) Inform the individual in writing of his or her right to
- 16 appeal the denial or notice of statutory disqualification to the
- 17 circuit court as provided in section 5d.
- 18 (c) Inform the individual that he or she should contact the
- 19 source of the record for any statutory disqualification to correct
- 20 any errors in the record resulting in the statutory
- 21 disqualification.
- 22 (14) If a license or notice of statutory disqualification is
- 23 not issued under subsection (13) within 45 days after the date the
- 24 individual has classifiable fingerprints taken under subsection
- 25 (9), the receipt issued under subsection (9) serves as a concealed
- 26 pistol license for purposes of this act when carried with a state-
- 27 issued driver license or personal identification card and is valid

- 1 until a license or notice of statutory disqualification is issued
- 2 by the county clerk.
- 3 (15) If an individual licensed under this act to carry a
- 4 concealed pistol moves to a different county within this state, his
- 5 or her license remains valid until it expires or is otherwise
- 6 suspended or revoked under this act. An individual may notify a
- 7 county clerk IN WRITING OR IN PERSON that he or she has moved to a
- 8 different address within this state for the purpose of receiving
- **9** the notice under section 5l(1). A license to carry a concealed
- 10 pistol that is lost, stolen, defaced, or replaced for any other
- 11 reason, may INCLUDING ADDING OR REMOVING AN EXEMPTION FROM SECTION
- 12 50, MUST be replaced by the issuing county clerk for a replacement
- 13 fee of \$10.00. A COUNTY CLERK SHALL ALLOW AN INDIVIDUAL TO OBTAIN A
- 14 REPLACEMENT LICENSE BY MAIL WITHOUT REQUIRING THE INDIVIDUAL TO
- 15 APPEAR IN PERSON. IF AN INDIVIDUAL WISHES TO TRANSFER A LICENSE TO
- 16 A NEW COUNTY OF RESIDENCE, THE COUNTY CLERK OF THAT NEW COUNTY OF
- 17 RESIDENCE SHALL CHARGE THAT INDIVIDUAL A FEE OF \$25.00 AND ISSUE A
- 18 NEW LICENSE TO THE INDIVIDUAL. THE COUNTY CLERK IS RESPONSIBLE FOR
- 19 NOTIFYING THE PREVIOUS COUNTY CLERK THAT HE OR SHE IS NO LONGER
- 20 RESPONSIBLE FOR MAINTAINING THE LICENSE. A county clerk shall
- 21 deposit a replacement fee under this subsection in the concealed
- 22 pistol licensing fund of that county created in section 5x.
- 23 (16) If a license issued under this act is suspended or
- 24 revoked, the license is forfeited and the individual shall return
- 25 the license to the county clerk forthwith by mail or in person. The
- 26 county clerk shall retain a suspended or revoked license as an
- 27 official record 1 year after the expiration of the license, unless

- 1 the license is reinstated or a new license is issued. The county
- 2 clerk shall notify the department of state police if a license is
- 3 suspended or revoked. The department of state police shall enter
- 4 that suspension or revocation into the law enforcement information
- 5 network. An individual who fails to return a license as required
- 6 under this subsection after he or she was notified that his or her
- 7 license was suspended or revoked is guilty of a misdemeanor
- 8 punishable by imprisonment for not more than 93 days or a fine of
- 9 not more than \$500.00, or both.
- 10 (17) An applicant or an individual licensed under this act to
- 11 carry a concealed pistol may be furnished a copy of his or her
- 12 application under this section upon request and the payment of a
- 13 reasonable fee not to exceed \$1.00. The county clerk shall deposit
- 14 any fee collected under this subsection in the concealed pistol
- 15 licensing fund of that county created in section 5x.
- 16 (18) This section does not prohibit the county clerk from
- 17 making public and distributing to the public at no cost lists of
- 18 individuals who are certified as qualified instructors as
- 19 prescribed under section 5j.
- 20 (19) A county clerk issuing an initial STANDARD OR LIFETIME
- 21 license, REPLACEMENT STANDARD OR LIFETIME LICENSE, or renewal
- 22 STANDARD license under this act shall mail the license to the
- 23 licensee by first-class mail in a sealed envelope. Upon payment of
- 24 the fee under subsection (15), a county clerk shall issue a
- 25 replacement license in person at the time of application for a
- 26 replacement license. A county clerk may also deliver a replacement
- 27 license by first-class mail if the individual submits to the clerk

- 1 a written request and a copy of the individual's state-issued
- 2 driver license or personal identification card.

- 13 subsection, the county clerk shall notify the department of state
- 14 police. The department of state police shall enter into the law
- 15 enforcement information network that the license was voluntarily
- 16 surrendered and the date the license was voluntarily surrendered.
- 17 (22) AN INDIVIDUAL MAY OBTAIN BOTH A STANDARD LICENSE AND A
- 18 LIFETIME LICENSE UNDER THIS SECTION.
- 19 (23)  $\frac{(22)}{}$  As used in this section:
- (a) "Acceptable proof" means any of the following:
- 21 (i) For a retired police officer or retired law enforcement
- 22 officer, the officer's retired identification or a letter from a
- 23 law enforcement agency stating that the retired police officer or
- 24 law enforcement officer retired in good standing.
- (ii) For an individual who is employed or contracted by an
- 26 entity described under section 50(1) to provide security services,
- 27 a letter from that entity stating that the employee is required by

- 1 his or her employer or the terms of a contract to carry a concealed
- 2 firearm on the premises of the employing or contracting entity and
- 3 his or her employee identification.
- 4 (iii) For an individual who is licensed as a private
- 5 investigator or private detective under the professional

- 3 of a law of the United States or another state that is designated
- 4 as a felony or that is punishable by death or by imprisonment for
- 5 more than 1 year. Felony does not include a violation of a penal
- 6 law of this state that is expressly designated as a misdemeanor.
- 7 (d) "Mental illness" means a substantial disorder of thought
- 8 or mood that significantly impairs judgment, behavior, capacity to
- 9 recognize reality, or ability to cope with the ordinary demands of
- 10 life, and includes, but is not limited to, clinical depression.
- 11 (e) "Misdemeanor" means a violation of a penal law of this
- 12 state or violation of a local ordinance substantially corresponding
- 13 to a violation of a penal law of this state that is not a felony or
- 14 a violation of an order, rule, or regulation of a state agency that
- 15 is punishable by imprisonment or a fine that is not a civil fine,
- 16 or both.

- 20 Sec. 5c. (1) A license to carry a concealed pistol shall MUST
- 21 be in a form, with the same dimensions as a Michigan operator
- 22 license, prescribed by the department of state police. Beginning
- 23 December 1, 2015, the THE license shall MUST be constructed of
- 24 plastic laminated paper or hard plastic. No AN additional fee shall

- 27 by offense, the total number of individuals licensed to carry a

- 1 concealed pistol convicted of a crime, and the total number of
- 2 those criminal convictions categorized by offense.
- 3 (j) The number of suicides by individuals licensed to carry a
- 4 concealed pistol.
- 5 (k) The total amount of revenue the department of state police
- 6 has received under this act.
- 7 (l) Actual costs incurred per initial and renewal—license by
- 8 the department of state police under this act, itemized by each
- 9 statutory section of this act.
- 10 (m) A list of expenditures made by the department of state
- 11 police from money received under this act, regardless of purpose.
- 12 (n) Actual costs incurred per permit for each county clerk.
- 13 (o) The number of times the database was accessed, categorized
- 14 by the purpose for which the database was accessed.
- 15 Sec. 5l. (1) A **STANDARD** license to carry a concealed pistol,
- 16 including a renewal license, is valid until the applicant's date of
- 17 birth that falls not less than 4 years or more than 5 years after
- 18 the license is issued or renewed, as applicable. A LIFETIME LICENSE
- 19 IS VALID UNTIL THAT LICENSE IS SUSPENDED OR REVOKED AS PROVIDED

- 8 applicant except as specifically authorized in this act. The
- 9 applicant shall pay the application and licensing fee to the state.
- 10 The state treasurer shall forward \$36.00 of each fee collected
- 11 under this subsection to the county treasurer who shall deposit the
- 12 \$36.00 in the concealed pistol licensing fund of that county
- 13 created in section 5x. The state treasurer shall deposit the
- 14 balance of the fee in the general fund to the credit of the
- 15 department of state police. The department of state police shall
- 16 notify the county clerk of the county in which the applicant
- 17 resides of a properly submitted online application or application
- 18 by first-class mail received by the department. If the county clerk
- 19 issues a renewal license under this section, the county clerk shall
- 20 send the license to the licensee by first-class mail in a sealed
- 21 envelope. If the county clerk issues the renewal, the effective
- 22 date of the renewal license is the date of expiration of the
- 23 current license or the date of approval or issue of the renewal,
- 24 whichever is later, and the date of expiration is the applicant's
- 25 date of birth which is not less than 4 years or more than 5 years
- 26 from the effective date of the license.
- 27 (3) The department of state police shall complete the

- 1 verification required under section 5b(6) and the county clerk
- 2 shall issue a renewal license or a notice of statutory
- 3 disqualification within 30 days after the date the renewal
- 4 application was received. Beginning on the date the department of
- 5 state police establishes a system under subsection (2), the
- 6 department of state police shall provide an applicant a digital
- 7 receipt, or a receipt by first-class mail if requested, for his or
- 8 her renewal application submitted online at the time the
- 9 application is received by the department of state police.
- 10 Beginning on the date the department of state police establishes a
- 11 system under subsection (2), the department of state police shall
- 12 mail an applicant a receipt by first-class mail for his or her
- 13 renewal application submitted by first-class mail at the time the
- 14 application is received by the department of state police. The
- 15 receipt issued under this subsection to an individual applying for
- 16 a renewal license whose current license is not expired at the time
- 17 of application must contain all of the following:
- (a) The name of the applicant.
- 19 (b) The date and time the receipt is issued.
- 20 (c) The amount paid.
- 21 (d) The applicant's state-issued driver license or personal
- 22 identification card number.
- (e) The statement "This receipt was issued for the purpose of
- 24 renewal of a concealed pistol license. As provided in section 5l of
- 25 1927 PA 372, MCL 28.425l, this receipt shall serve as a concealed
- 26 pistol license for the individual named in the receipt when carried
- 27 with the expired license and is valid until a license or notice of

- 1 statutory disqualification is issued by the county clerk. This
- 2 receipt does not exempt the individual named in the receipt from
- 3 complying with all applicable laws for the purchase of firearms.".
- 4 (f) The name of the county in which the receipt is issued, if
- **5** applicable.
- 6 (g) An impression of the county seal, if applicable.
- 7 (4) The receipt issued under subsection (3) to an individual
- 8 applying for a renewal license whose license is expired must
- 9 contain all of the following:
- 10 (a) The name of the applicant.
- 11 (b) The date and time the receipt is issued.
- 12 (c) The amount paid.
- 13 (d) The applicant's state-issued driver license or personal
- 14 identification card number.
- 15 (e) The statement "This receipt was issued for the purpose of
- 16 renewal of a concealed pistol license. As provided in section 5l of
- 17 1927 PA 372, MCL 28.425l, if a license or notice of statutory
- 18 disqualification is not issued within 30 days after the date this
- 19 receipt was issued, this receipt shall serve as a concealed pistol
- 20 license for the individual named in the receipt when carried with
- 21 an official state-issued driver license or personal identification
- 22 card. The receipt is valid as a license until a license or a notice
- 23 of statutory disqualification is issued by the county clerk. This
- 24 receipt does not exempt the individual named in the receipt from
- 25 complying with all applicable laws for the purchase of firearms.".
- 26 (5) Until November 30, 2018, a member of the United States
- 27 Armed Forces, the United States Armed Forces Reserve, or the

- 1 Michigan National Guard who is on orders to a duty station outside
- 2 of this state may submit his or her application to renew a license
- 3 to carry a concealed pistol by first-class mail, containing the
- 4 required fee, a notarized application, the licensee's address of
- 5 record within the state, the licensee's orders to report to a duty
- 6 station outside of this state, and if the licensee desires to have
- 7 his or her application receipt, renewal license, or any other
- 8 notices mailed to his or her address of assignment or deployment, a
- 9 letter requesting that action including the address of assignment
- 10 or deployment. If the county clerk issues a renewal license under
- 11 this section, the county clerk shall send the license to the
- 12 licensee by first-class mail in a sealed envelope. If the licensee
- 13 is a member of the United States Armed Forces, the United States
- 14 Armed Forces Reserve, or the Michigan National Guard who is on
- 15 orders to a duty station outside of this state and requests that
- 16 his or her license be sent to the address of assignment or
- 17 deployment, the county clerk shall mail the license to the licensee
- 18 at the address of assignment or deployment provided in the renewal
- 19 application. Until November 30, 2018, if a renewal application is
- 20 submitted by a member of the United States Armed Forces, the United
- 21 States Armed Forces Reserve, or the Michigan National Guard who is
- 22 on orders to a duty station outside of this state, the county clerk
- 23 shall mail a receipt to the licensee by first-class mail.
- 24 (6) If an individual applies for a renewal license before the
- 25 expiration of his or her license, the expiration date of the
- 26 current license is extended until the renewal license or notice of
- 27 statutory disqualification is issued. The county clerk shall notify

- 1 the department of state police in a manner prescribed by the
- 2 department of state police after he or she receives an application
- 3 for renewal. The department of state police shall immediately enter
- 4 into the law enforcement information network the date that
- 5 application for renewal was submitted and that the renewal
- 6 application is pending.
- 7 (7) A person carrying a concealed pistol after the expiration
- 8 date of his or her STANDARD license under an extension under
- 9 subsection (6) shall keep the receipt issued by the county clerk
- 10 under subsection (3) and his or her expired STANDARD license in his
- 11 or her possession at all times that he or she is carrying the
- 12 pistol UNDER THE AUTHORITY OF A STANDARD LICENSE. For the purposes
- 13 of this act, the receipt is considered to be part of the license to
- 14 carry a concealed pistol until a renewal license is issued or
- 15 denied or a notice of statutory disqualification is issued.
- 16 (8) The educational requirements under section 5b(7)(c) are
- 17 waived for an applicant who is a retired police officer or retired
- 18 law enforcement officer.
- 19 (9) The educational requirements under section 5b(7)(c) for an
- 20 applicant who is applying for a renewal of a license under this act
- 21 are waived except that the applicant shall certify that he or she
- 22 has completed at least 3 hours' review of the training described
- 23 under section 5b(7)(c) and has had at least 1 hour of firing range
- 24 time in the 6 months immediately preceding the subsequent
- 25 application. The educational and firing range requirements of this
- 26 subsection are met if the applicant certifies on the renewal
- 27 application form that he or she has complied with the requirements

- 1 of this subsection. An applicant is not required to verify the
- 2 statements made under this subsection and is not required to obtain
- 3 a certificate or undergo training other than as required by this
- 4 subsection.
- 5 (10) An applicant who is applying for a renewal of a license
- 6 issued under section 5b is not required to have fingerprints taken
- 7 again under section 5b(9) if all of the following conditions have
- 8 been met:
- 9 (a) There has been established a system for the department of
- 10 state police to save and maintain in its automated fingerprint
- 11 identification system (AFIS) database all fingerprints that are
- 12 submitted to the department of state police under section 5b.
- 13 (b) The applicant's fingerprints have been submitted to and
- 14 maintained by the department of state police as described in
- 15 subdivision (a) for ongoing comparison with the automated
- 16 fingerprint identification system (AFIS) database.
- 17 Enacting section 1. Section 5h of 1927 PA 372, MCL 28.425h, is
