## **HOUSE BILL No. 5523**

February 6, 2018, Introduced by Reps. Kahle, Sheppard, LaFave, Bellino, Theis and Miller and referred to the Committee on Insurance.

A bill to amend 1982 PA 162, entitled

"Nonprofit corporation act,"

by amending section 209 (MCL 450.2209), as amended by 2014 PA 557.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 209. (1) The articles of incorporation may contain any provision that is not inconsistent with this act and not expressly prohibited by any other statute of this state, including, but not limited to, any of the following:

(a) A provision for management of the business and conduct of the affairs of the corporation, or creating, defining, limiting, or regulating the powers of the corporation, its directors, officers, members, or shareholders, or a class of directors, shareholders, or

- 9 (i) The amount of a financial benefit received by a director
- 10 or volunteer officer to which he or she is not entitled.
- (ii) Intentional infliction of harm on the corporation, its

- 14 (iv) An intentional criminal act.
- 15 (v) A liability imposed under section 497(a).
- 16 (d) For a corporation whose purposes, structures, and
- 17 activities are exclusively those described in section 501(c)(3) of
- 18 the internal revenue code of 1986, 26 USC 501, a provision that the
- 19 corporation assumes all liability to any person other than the
- 20 corporation, its shareholders, or its members for all acts or
- 21 omissions of a volunteer director occurring on or after January 1,
- 22 1988 incurred in the good faith performance of the volunteer
- 23 director's duties.
- 24 (e) A provision that the corporation assumes the liability for
- 25 all acts or omissions of a volunteer director, volunteer officer,
- 26 or other volunteer occurring on or after the effective date of the
- 27 provision that grants limited liability if all of the following are

- 7 (iv) The volunteer's conduct was not an intentional tort.

- 12 (f) A provision that reserves to 1 or more members,
- 13 shareholders, or other persons all or part of the authority to
- 14 exercise the corporate powers or to manage the business and affairs
- 15 of the corporation, including the resolution of any issue about
- 16 which there exists a deadlock among directors, shareholders, or
- 17 members. A provision authorized under this subsection that limits
- 18 the discretion or powers of the board relieves the directors of,
- 19 and imposes on the person or persons in which the discretion or
- 20 powers are vested, liability for acts or omissions imposed by law
- 21 on directors to the extent that the discretion or powers of the
- 22 directors are limited by the provision. The person or persons in
- 23 which the discretion or powers are vested are treated as a director
- 24 or directors for the purposes of any limitation or assumption of
- 25 liability under this section and, except as otherwise provided in
- 26 the articles of incorporation or bylaws, have the same rights and
- 27 obligations with respect to indemnification as a director or
