A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 509ii.

- 1 SEC. 509II. (1) NOT LATER THAN DECEMBER 31, 2018, THE
- 2 SECRETARY OF STATE SHALL DEVELOP AND MAINTAIN AN ELECTRONIC VOTER
- 3 REGISTRATION INTERFACE TO ALLOW AN APPLICANT TO SUBMIT A VOTER
- 4 REGISTRATION APPLICATION ELECTRONICALLY THROUGH THE SECRETARY OF
- 5 STATE'S WEBSITE. THE ELECTRONIC VOTER REGISTRATION INTERFACE MUST
- 6 DO ALL OF THE FOLLOWING:
 - (A) TRANSMIT THE APPLICATION TO THE QUALIFIED VOTER FILE.
- 8 (B) INTERACT WITH THE STATE OPERATOR'S OR CHAUFFEUR'S LICENSE
 - FILE AND THE OFFICIAL STATE PERSONAL IDENTIFICATION CARD FILE FOR

- 13 (4) IF AN ELECTOR UTILIZES THE ELECTRONIC VOTER REGISTRATION
- 14 INTERFACE TO INDICATE A CHANGE OF ADDRESS, THE STATE BUREAU OF
- 15 ELECTIONS SHALL SEND A CONFIRMATION NOTICE TO THE ELECTOR'S
