

# HOUSE BILL No. 5599

February 20, 2018, Introduced by Reps. Garcia, Kelly, Crawford, Lilly, Hornberger, Griffin and Zemke and referred to the Committee on Education Reform.

A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
(MCL 380.1 to 380.1852) by adding section 1538c.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           **SEC. 1538C. (1) THE SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL**  
2           **NOT APPROVE A TEACHER PREPARATION INSTITUTION UNDER SECTION 1538A**  
3           **AND R 390.1151 TO R 390.1153 OF THE MICHIGAN ADMINISTRATIVE CODE**  
4           **UNLESS THE TEACHER PREPARATION INSTITUTION OFFERS A WARRANTY**

5           **EDUCATION PROGRAM TO INDIVIDUALS WHO MEET ALL OF THE FOLLOWING:**

6           **(A) THE INDIVIDUAL COMPLETED A TEACHER PREPARATION PROGRAM AT**  
7           **A TEACHER PREPARATION INSTITUTION IN THIS STATE.**

8           **(B) THE INDIVIDUAL IS EMPLOYED TO TEACH IN A SCHOOL OPERATED**  
9           **BY A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, PUBLIC SCHOOL**  
10          **ACADEMY, OR NONPUBLIC SCHOOL.**

1 (C) NOT LATER THAN 2 YEARS AFTER THE INDIVIDUAL GRADUATED FROM  
2 A TEACHER PREPARATION INSTITUTION, THE GOVERNING BODY OF THE SCHOOL  
3 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, OR  
4 NONPUBLIC SCHOOL EMPLOYING THE INDIVIDUAL DETERMINES THAT THE  
5 INDIVIDUAL LACKS THE SKILLS TO EFFECTIVELY TEACH STUDENTS, BASED ON  
6 AT LEAST BOTH OF THE FOLLOWING:

7 (i) A LOCAL EVALUATION TOOL.

8 (ii) A DEVELOPMENT PLAN THAT IDENTIFIES SPECIFIC AREAS OF  
9 INSTRUCTIONAL DEVELOPMENT THAT ARE MOST EFFECTIVELY ADDRESSED BY  
10 FURTHER TEACHER PREPARATION INSTRUCTION, AS DETERMINED BY THE  
11 GOVERNING BODY OF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL  
12 DISTRICT, PUBLIC SCHOOL ACADEMY, OR NONPUBLIC SCHOOL.

13 (2) AN INDIVIDUAL WHO MEETS THE REQUIREMENTS UNDER SUBSECTION  
14 (1) MAY ENROLL IN A WARRANTY EDUCATION PROGRAM UNDER SUBSECTION (1)  
15 AT ANY TEACHER PREPARATION INSTITUTION APPROVED BY THE  
16 SUPERINTENDENT OF PUBLIC INSTRUCTION. THE TEACHER PREPARATION  
17 INSTITUTION FROM WHICH THE INDIVIDUAL GRADUATED MUST BEAR THE COST  
18 OF THE WARRANTY EDUCATION PROGRAM IN WHICH THE INDIVIDUAL ENROLLS  
19 UNDER THIS SUBSECTION.

20 (3) AN INDIVIDUAL WHO ENROLLS IN A WARRANTY EDUCATION PROGRAM  
21 UNDER THIS SECTION SHALL NOT USE ANY CREDITS EARNED UNDER THE  
22 WARRANTY EDUCATION PROGRAM TOWARD THE COMPLETION OF A MASTER'S  
23 DEGREE.

24 (4) THE DEPARTMENT SHALL PROMULGATE RULES TO IMPLEMENT THIS  
25 SECTION.

26 Enacting section 1. This amendatory act takes effect 90 days  
27 after the date it is enacted into law.
