A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 17751a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17751A. (1) SUBJECT TO THIS SECTION, SECTION 17751, AND
- 2 SECTION 17755, IF AN INDIVIDUAL REQUESTS A CONTRACEPTIVE THAT IS IN
- 3 STOCK IN A PHARMACY, THE PHARMACY SHALL ENSURE THAT THE
- 4 CONTRACEPTIVE IS PROVIDED TO THE INDIVIDUAL WITHOUT DELAY. SUBJECT
- 5 TO THIS SECTION, SECTION 17751, AND SECTION 17755, IF AN INDIVIDUAL
- 6 REQUESTS A CONTRACEPTIVE THAT IS NOT IN STOCK IN THE PHARMACY, THE
- 7 PHARMACY SHALL ENSURE THAT THE INDIVIDUAL IS IMMEDIATELY INFORMED
- 8 THAT THE CONTRACEPTIVE IS NOT IN STOCK AND IS OFFERED THE FOLLOWING
- OPTIONS WITHOUT DELAY:

- 1 (A) IF THE INDIVIDUAL PREFERS TO OBTAIN THE CONTRACEPTIVE
- 2 THROUGH A REFERRAL OR TRANSFER, A PHARMACIST SHALL LOCATE A

- 6 (B) IF THE INDIVIDUAL PREFERS FOR THE PHARMACY TO ORDER THE

- 8 THE PHARMACY'S STANDARD PROCEDURES FOR EXPEDITED ORDERING OF DRUGS
- 9 AND NOTIFY THE CUSTOMER WHEN THE CONTRACEPTIVE ARRIVES.
- 10 (2) A PHARMACY SHALL ENSURE THAT ANY INDIVIDUAL EMPLOYED BY
- 11 THE PHARMACY DOES NOT DO ANY OF THE FOLLOWING:
- 12 (A) INTIMIDATE, THREATEN, OR HARASS AN INDIVIDUAL IN THE
- 13 DELIVERY OF SERVICES RELATING TO A REQUEST FOR CONTRACEPTION.
- 14 (B) INTERFERE WITH OR OBSTRUCT THE DELIVERY OF SERVICES
- 15 RELATING TO A REQUEST FOR CONTRACEPTION.
- 16 (C) INTENTIONALLY MISREPRESENT OR DECEIVE AN INDIVIDUAL ABOUT
- 17 THE AVAILABILITY OF CONTRACEPTION OR ITS MECHANISM OF ACTION.
- 18 (D) BREACH MEDICAL CONFIDENTIALITY WITH RESPECT TO A REQUEST
- 19 FOR CONTRACEPTION OR THREATEN TO BREACH THAT CONFIDENTIALITY.
- 20 (E) UPON THE INDIVIDUAL'S REQUEST, REFUSE TO RETURN TO THE
- 21 INDIVIDUAL AN UNFILLED VALID PRESCRIPTION FOR CONTRACEPTION.
- 22 (3) THIS SECTION DOES NOT PROHIBIT A PHARMACY FROM REFUSING TO
- 23 PROVIDE A CONTRACEPTIVE TO AN INDIVIDUAL IF 1 OR MORE OF THE
- 24 FOLLOWING CIRCUMSTANCES OCCUR:
- 25 (A) IT IS UNLAWFUL TO DISPENSE THE CONTRACEPTIVE TO THE
- 26 INDIVIDUAL WITHOUT A VALID PRESCRIPTION AND THE INDIVIDUAL DOES NOT
- 27 PRESENT A VALID PRESCRIPTION.

- 1 (B) THE INDIVIDUAL IS UNABLE TO PAY FOR THE CONTRACEPTIVE.
- 2 (C) A PHARMACIST WHO IS EMPLOYED BY THE PHARMACY REFUSES TO
- 3 PROVIDE THE CONTRACEPTIVE BASED ON HIS OR HER PROFESSIONAL CLINICAL
- 4 JUDGMENT.
- 5 (4) A PHARMACY SHALL ENSURE THAT OVER-THE-COUNTER EMERGENCY
- 6 CONTRACEPTION IS STOCKED AND MADE AVAILABLE FOR PURCHASE WITHOUT A
- 7 PRESCRIPTION IN ACCORDANCE WITH FOOD AND DRUG ADMINISTRATION
- 8 PROTOCOL.
- 9 (5) AN INDIVIDUAL AGGRIEVED AS A RESULT OF A VIOLATION OF THIS
- 10 SECTION MAY COMMENCE A CIVIL ACTION AGAINST THE PHARMACY INVOLVED
- 11 TO OBTAIN APPROPRIATE RELIEF, INCLUDING ACTUAL AND PUNITIVE
- 12 DAMAGES, INJUNCTIVE RELIEF, AND REASONABLE ATTORNEY FEES AND COSTS.
- 13 (6) AS USED IN THIS SECTION:
- 14 (A) "CONTRACEPTION" OR "CONTRACEPTIVE" MEANS A PRODUCT TO
- 15 PREVENT PREGNANCY.
- 16 (B) "EMERGENCY CONTRACEPTION" MEANS 1 OR MORE DRUGS, USED
- 17 SEPARATELY OR IN COMBINATION WITH ONE ANOTHER, TO PREVENT PREGNANCY
- 18 WITHIN A MEDICALLY RECOMMENDED AMOUNT OF TIME AFTER SEXUAL
- 19 INTERCOURSE.
- 20 (C) "PRODUCT" MEANS A DRUG OR DEVICE THAT IS APPROVED BY THE
- 21 FOOD AND DRUG ADMINISTRATION.
- 22 (D) "PROFESSIONAL CLINICAL JUDGMENT" MEANS THE USE OF
- 23 PROFESSIONAL KNOWLEDGE AND SKILL TO FORM A CLINICAL JUDGMENT IN
- 24 ACCORDANCE WITH PREVAILING MEDICAL STANDARDS.
- 25 (E) "WITHOUT DELAY" MEANS WITHIN THE USUAL AND CUSTOMARY TIME
- 26 FRAME AT THE PHARMACY FOR DISPENSING, PROVIDING A REFERRAL FOR, OR
- 27 ORDERING A PRODUCT, OR TRANSFERRING A PRESCRIPTION FOR A PRODUCT,
