

HOUSE BILL No. 5630

February 22, 2018, Introduced by Reps. Lucido, Chirkun, Dianda, Marino, Green and LaFave and referred to the Committee on Insurance.

A bill to amend 1982 PA 432, entitled
"Motor bus transportation act,"
by amending section 10 (MCL 474.110), as added by 2016 PA 349.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 10. (1) An applicant shall acquire the following
2 liability insurance coverage for acts or omissions of the applicant
3 as a motor carrier:

4 (a) For buses with a seating capacity of between 9 and 15
5 passengers, including the driver, bodily injury and property damage
6 liability insurance with a minimum combined single limit of
7 \$1,500,000.00 for all persons injured or for property damage.

8 (b) For buses with a seating capacity of 16 or more
9 passengers, including the driver, bodily injury and property damage
10 liability insurance with a minimum combined single limit of
11 \$5,000,000.00 for all persons injured or for property damage.

1 (c) Personal protection insurance and property protection
2 insurance as ~~required by~~ **DESCRIBED IN** chapter 31 of the insurance
3 code of 1956, 1956 PA 218, MCL 500.3101 to 500.3179.

4 (2) A motor carrier shall maintain the insurance coverage
5 described in subsection (1) as a condition of maintaining an
6 authority issued under this act. For each authorized seasonal
7 vehicle, a motor carrier shall maintain the insurance coverage
8 described in subsection (1) during the approved seasonal period.

9 (3) The insurance requirements of subsection (1) are waived if
10 the applicant qualifies for and obtains a certificate of self-
11 insurance from the commissioner of the office of financial and
12 insurance services under section 3101d of the insurance code of
13 1956, 1956 PA 218, MCL 500.3101d.

14 (4) Except as otherwise provided in this act, if a motor
15 carrier cancels the insurance coverage required under this section
16 for any reason or if the coverage level falls below the levels
17 provided in subsection (1), the authority issued to that motor
18 carrier is automatically revoked.

19 (5) A motor carrier shall grant notification rights to the
20 department for all insurance policies required under this act to
21 ensure that the department is notified of all activities related to
22 the policy, including cancellation and replacement.

23 Enacting section 1. This amendatory act takes effect January
24 1, 2019.

25 Enacting section 2. This amendatory act does not take effect
26 unless all of the following bills of the 99th Legislature are
27 enacted into law:
