HOUSE BILL No. 5791

April 12, 2018, Introduced by Reps. Chang, Pagan, Hoadley, Iden, Greimel, Hauck, Geiss, Kesto, Clemente and Rabhi and referred to the Committee on Law and Justice.

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 1508 and 1526b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1508. (1) NOT LATER THAN JUNE 1, 2019, IN CONSULTATION
- 2 WITH EXPERTS ON SEXUAL ASSAULT AND SEXUAL HARASSMENT, INCLUDING,
 - BUT NOT LIMITED TO, THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE
- 4 PREVENTION AND TREATMENT BOARD AND THE MICHIGAN COALITION TO END
- 5 DOMESTIC AND SEXUAL VIOLENCE, THE DEPARTMENT SHALL DEVELOP AGE-
- 6 APPROPRIATE INFORMATIONAL MATERIAL RELATING TO SEXUAL ASSAULT AND
- 7 SEXUAL HARASSMENT AND MAKE THAT MATERIAL AVAILABLE TO ALL SCHOOL
- 8 DISTRICTS, INTERMEDIATE SCHOOL DISTRICTS, AND PUBLIC SCHOOL
- 9 ACADEMIES THAT OPERATE ANY OF GRADES 6 TO 12. THE INFORMATIONAL
- 10 MATERIAL MUST BE RELEVANT TO THE COMMUNITIES SERVED AND INCLUDE AT

- 6 (C) RESOURCES AVAILABLE FOR INDIVIDUALS WHO HAVE EXPERIENCED
- 7 SEXUAL ASSAULT OR SEXUAL HARASSMENT, INCLUDING, BUT NOT LIMITED TO,
- 8 INFORMATION ON TITLE IX, AS ENACTED UNDER THE EDUCATION AMENDMENTS
- 9 OF 1972, 20 USC 1681 TO 1688, APPROPRIATE CONTACT INFORMATION FOR
- 10 ORGANIZATIONS THAT OFFER ASSISTANCE TO VICTIMS OF SEXUAL ASSAULT OR
- 11 SEXUAL HARASSMENT, AND ACTIONS THAT THE INDIVIDUAL MAY TAKE.
- 12 (2) A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 13 SCHOOL ACADEMY SHALL DISSEMINATE THE INFORMATIONAL MATERIAL MADE
- 14 AVAILABLE BY THE DEPARTMENT UNDER SUBSECTION (1) TO EACH PUPIL IN
- 15 GRADES 6 TO 12 WHO IS ENROLLED IN A SCHOOL OPERATED BY THE SCHOOL
- 16 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY.
- 17 ADDITIONALLY, THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
- 18 PUBLIC SCHOOL ACADEMY SHALL DISSEMINATE TO THOSE PUPILS THE CONTACT
- 19 INFORMATION FOR THE SCHOOL DISTRICT'S, INTERMEDIATE SCHOOL
- 20 DISTRICT'S, OR PUBLIC SCHOOL ACADEMY'S TITLE IX COORDINATOR AND THE
- 21 SCHOOL DISTRICT'S, INTERMEDIATE SCHOOL DISTRICT'S, OR PUBLIC SCHOOL
- 22 ACADEMY'S POLICIES ON SEXUAL ASSAULT AND SEXUAL HARASSMENT,
- 23 INCLUDING SPECIFIC INFORMATION STATING WHETHER THE POLICIES
- 24 PROHIBIT ADVERSE ACTION AGAINST AN INDIVIDUAL FOR REPORTING SEXUAL
- 25 ASSAULT OR SEXUAL HARASSMENT. THE SCHOOL DISTRICT, INTERMEDIATE
- 26 SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL ENSURE THAT ALL THE
- 27 INFORMATION DESCRIBED IN THIS SUBSECTION REMAINS ACCESSIBLE TO

- 8 SEC. 1526B. BEGINNING IN THE 2019-2020 SCHOOL YEAR, THE BOARD
- 9 OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR BOARD OF
- 10 DIRECTORS OF A PUBLIC SCHOOL ACADEMY, TOGETHER WITH A LOCAL
- 11 ORGANIZATION THAT RECEIVES FUNDING FROM THE MICHIGAN DOMESTIC AND
- 12 SEXUAL VIOLENCE PREVENTION AND TREATMENT BOARD AND THAT SERVES THE
- 13 GEOGRAPHIC AREA OF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 14 DISTRICT, OR PUBLIC SCHOOL ACADEMY, IS ENCOURAGED TO PROVIDE ALL
- 15 EDUCATORS AND SCHOOL PERSONNEL WHO HAVE CONTACT WITH PUPILS
- 16 TRAINING AT LEAST EVERY 5 YEARS IN RESPONDING TO PUPILS WHO HAVE
- 17 EXPERIENCED SEXUAL ASSAULT OR SEXUAL HARASSMENT. THIS TRAINING MAY
- 18 BE PROVIDED AS PART OF THE PROFESSIONAL DEVELOPMENT PROVIDED UNDER
- 19 SECTION 1527. IF A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT,
- 20 OR PUBLIC SCHOOL ACADEMY IS LOCATED IN AN AREA WITHOUT A LOCAL
- 21 ORGANIZATION THAT RECEIVES FUNDING FROM THE MICHIGAN DOMESTIC AND
- 22 SEXUAL VIOLENCE PREVENTION AND TREATMENT BOARD, THE SCHOOL
- 23 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY IS
- 24 ENCOURAGED TO PROVIDE THE TRAINING DESCRIBED IN THIS SECTION
- 25 TOGETHER WITH THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE PREVENTION
- 26 AND TREATMENT BOARD OR THE MICHIGAN COALITION TO END DOMESTIC AND
- 27 SEXUAL VIOLENCE.
