THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 819. (1) Except as otherwise provided in this section,
 revenue from the increases in fees provided in 1987 PA 232 shall be
 deposited in the transportation economic development fund
 established in section 2 of 1987 PA 231, MCL 247.902, and shall not
 be appropriated for any other purpose in any act making
 appropriations of state funds.
 - (2) For the fiscal year ending September 30, 1989, and each fiscal year thereafter, of the revenue from the increases in fees provided in 1987 PA 232, \$2,500,000.00 shall be deposited in the state treasury and credited to the general fund, except that not
