HOUSE BILL No. 5849

April 19, 2018, Introduced by Reps. Green, Ellison, Marino, Elder, Howrylak, Zemke, Hertel, Yancey, Pagan, Lucido, Brann and Rabhi and referred to the Committee on Health Policy.

A bill to amend 2014 PA 462, entitled

"An act to allow peace officers to carry and administer opioid antagonists in certain circumstances; to provide access to opioid antagonists by law enforcement agencies and peace officers; and to limit the civil and criminal liability of law enforcement agencies and peace officers for the possession, distribution, and use of opioid antagonists under certain circumstances,"

by amending section 1 (MCL 28.541).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. As used in this act:

- (a) "Law enforcement agency" means an entity of this state or of a local unit of government of this state that employs peace officers.
- (b) "Opioid antagonist" means naloxone hydrochloride or any other similarly acting and equally safe drug approved by the
- federal food and drug administration FOOD AND DRUG ADMINISTRATION

- 2 but not limited to, extreme physical illness, decreased level of

- 6 believe to be an opioid-related overdose that requires medical

- 8 (d) "Peace officer" means 1 or more of the following:
- 9 (i) A regularly employed member of a law enforcement agency

- 11 responsible for the prevention and detection of crime and the
- 12 enforcement of the general criminal laws of this state. Peace
- 13 officer does not include a person serving solely because he or she
- 14 occupies any other office or position.
- 15 (ii) A law enforcement officer of a Michigan Indian tribal

- 17 (iii) The sergeant at arms or any assistant sergeant at arms
- 18 of either house of the legislature who is commissioned as a police
