HOUSE BILL No. 5851

April 19, 2018, Introduced by Reps. LaFave, Bellino and Iden and referred to the Committee on Appropriations.

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1308a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1308A. (1) AT LEAST ANNUALLY, A SCHOOL DISTRICT,
- 2 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL
- 3 PROVIDE A REPORT TO THE DEPARTMENT OF STATE POLICE, IN A FORM AND
- 4 MANNER PRESCRIBED BY THE DEPARTMENT OF STATE POLICE, ON BOTH OF THE
- 5 FOLLOWING TYPES OF INCIDENTS REGARDING A SCHOOL OPERATED BY THE
 - SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
 - ACADEMY:
- 8 (A) AN ATTEMPTED ACT OF VIOLENCE ON SCHOOL GROUNDS THAT WAS
- 9 PREVENTED OR THWARTED.
- 10 (B) A THREAT OF VIOLENCE MADE ON OR OFF SCHOOL GROUNDS THAT
 - WAS DIRECTED AT A SCHOOL, SCHOOL STAFF, OR PUPILS AND THAT WAS

- 2 (2) A REPORT UNDER SUBSECTION (1) MUST MEET BOTH OF THE
- 3 FOLLOWING:
- 4 (A) INCLUDE A DESCRIPTION OF THE INCIDENT AND HOW THE INCIDENT
- 5 WAS THWARTED OR PREVENTED.
- 6 (B) EXCLUDE THE NAME OF THE SCHOOL AFFECTED BY THE INCIDENT,
- 7 THE NAME OF ANY INDIVIDUAL INVOLVED IN THE INCIDENT, AND ANY OTHER
- 8 INFORMATION THAT WOULD IDENTIFY THE SCHOOL AFFECTED OR INDIVIDUAL
- 9 OR INDIVIDUALS INVOLVED IN THE INCIDENT.
- 10 (3) AT LEAST ANNUALLY, THE DEPARTMENT OF STATE POLICE SHALL
- 11 COMPILE A REPORT ON THE INFORMATION REPORTED UNDER SUBSECTION (1)
- 12 AND PROVIDE THE REPORT TO THE SCHOOL SAFETY COMMISSION CREATED
- 13 UNDER SECTION 5 OF THE COMPREHENSIVE SCHOOL SAFETY PLAN ACT, IN A
- 14 FORM AND MANNER PRESCRIBED BY THE DEPARTMENT OF STATE POLICE.
- 15 (4) A REPORT UNDER THIS SECTION IS EXEMPT FROM THE FREEDOM OF

- 17 Enacting section 1. This amendatory act takes effect 90 days
- 18 after the date it is enacted into law.
