THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the "local 2 government occupational licensing act".

- (a) "Licensing" means any training, education, or fee required 5 for an individual to perform work in a specific occupation in a 6 political subdivision, in this state, or in any other governmental unit in this state.
 - (b) "Licensing authority" means an agency, examining board, credentialing board, or other office of a political subdivision or other governmental unit that has the authority to impose fees or other licensing requirements on an individual as a condition to
