A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 3406u.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3406U. (1) AN INSURER PROVIDING A HEALTH POLICY
- 2 DELIVERED, ISSUED FOR DELIVERY, OR RENEWED IN THIS STATE SHALL
- 3 OFFER COVERAGE FOR MEDICALLY NECESSARY PROSTHETIC DEVICES AND
- 4 COMPONENTS AND FOR THEIR REPAIR, FITTING, AND REPLACEMENT.
 - (2) COVERAGE UNDER THIS SECTION IS NOT SUBJECT TO ANY OF THE FOLLOWING:
- (A) AN ANNUAL OR LIFETIME DOLLAR MAXIMUM OTHER THAN THE ANNUAL
- 8 OR LIFETIME DOLLAR MAXIMUM THAT APPLIES IN THE AGGREGATE TO ALL
 - ITEMS AND SERVICES COVERED UNDER THE HEALTH INSURANCE POLICY.

- 13 (A) "COMPONENT" MEANS THE MATERIALS AND EQUIPMENT NEEDED TO
- 14 ENSURE THE COMFORT AND FUNCTIONING OF A PROSTHETIC DEVICE.
- 15 (B) "LIMB" MEANS AN ARM, HAND, LEG, OR FOOT OR ANY PORTION OF
- 16 AN ARM, HAND, LEG, OR FOOT.
- 17 (C) "PROSTHETIC DEVICE" MEANS AN ARTIFICIAL DEVICE TO REPLACE,
- 18 IN WHOLE OR IN PART, A LIMB.

- 20 certificates, or contracts delivered, issued for delivery, renewed,
- 21 or extended on or after January 1, 2019 or when any term of the
