THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 17766G. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION

 (4), A PERSON SHALL NOT KNOWINGLY OR WILLFULLY SELL OR TRADE A

 FINISHED DRUG PRODUCT CONTAINING ANY QUANTITY OF DEXTROMETHORPHAN

 TO AN INDIVIDUAL WHO IS LESS THAN 18 YEARS OF AGE.
 - (2) A PERSON MAKING A RETAIL SALE OF A FINISHED DRUG PRODUCT CONTAINING ANY QUANTITY OF DEXTROMETHORPHAN MUST REQUIRE AND OBTAIN PROOF OF AGE FROM THE PURCHASER BEFORE COMPLETING THE SALE, UNLESS FROM THE PURCHASER'S OUTWARD APPEARANCE THE PERSON MAKING THE SALE WOULD REASONABLY PRESUME THE PURCHASER TO BE AT LEAST 25 YEARS OF AGE.
 - (3) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4), AN

- 26 (A) "DEXTROMETHORPHAN" MEANS THE DEXTROROTATORY ISOMER OF 3-
- 27 METHOXY-N-METHYL-MORPHINAN AND ITS SALTS.
