

HOUSE BILL No. 6090

May 30, 2018, Introduced by Rep. Bellino and referred to the Committee on Local Government.

A bill to amend 1939 PA 342, entitled
"County public improvement act of 1939,"
by amending section 6 (MCL 46.176).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 6. The **COUNTY** board of ~~supervisors~~**COMMISSIONERS** shall
2 designate either a committee selected from its membership or the
3 board of auditors, ~~in counties having boards of~~**IF A COUNTY HAS A**
4 **BOARD OF** auditors, to be constituted **AS** a board of review for the
5 purpose of hearing and reviewing rates, charges, ~~and/or~~**OR**
6 assessments. At the request of any unit of government, person,
7 firm, or corporation ~~charged~~ for services rendered by any county
8 acting under ~~the provisions hereof,~~**THIS ACT**, and on sufficient
9 cause being shown, or upon information presented to or obtained by
10 ~~said~~**THE** board of review of the respective county, the action of

1 the county agency in fixing or adjusting charges ~~and/or~~ **OR**
 2 assessments ~~shall~~ **MUST** be reviewed and finally determined by ~~said~~
 3 **THE** board of review. ~~÷ Provided, That such~~ **THE** charges ~~and/or~~ **OR**
 4 assessments ~~shall~~ **MUST** in all cases be sufficient to pay **THE**
 5 operating expenses of the system and to meet sinking fund and
 6 interest requirements on bonds and to meet principal and interest
 7 payments on notes if any, and any other requirements under which
 8 ~~such~~ **THE** bonds or notes may be issued. The board of review shall
 9 adjust and correct rates, charges, ~~and/or~~ **OR** assessments in order
 10 that the ~~same shall be~~ **RATES, CHARGES, OR ASSESSMENTS ARE** just and
 11 equitable. The board of review shall meet at the room of the **COUNTY**
 12 board of ~~supervisors~~ **COMMISSIONERS** in the county building ~~on the~~
 13 ~~second Monday in May and September of each year, at 3:00 o'clock in~~
 14 ~~the afternoon and continue in session during the day until 5:00~~
 15 ~~o'clock in the afternoon thereof and during the same hours of the 2~~
 16 ~~days following. Additional time for hearings may be granted by the~~
 17 ~~board of review.~~ **WITHIN 60 DAYS OF A WRITTEN REQUEST TO REVIEW**
 18 **RATES, CHARGES, OR ASSESSMENTS. THE BOARD OF REVIEW SHALL ALLOW**
 19 **SUFFICIENT TIME FOR THE HEARING.** Notice of hearings to be held by
 20 the board of review ~~shall~~ **MUST** be prepared by ~~such~~ **THE** board and
 21 posted at 2 public places in each municipality where rates,
 22 charges, ~~and/or~~ **OR** assessments are charged or assessed ~~in pursuance~~
 23 ~~hereof,~~ **UNDER THIS ACT** at least 7 days ~~prior to~~ **BEFORE** the ~~second~~
 24 ~~Monday in May and September.~~ **SCHEDULED HEARING.**
