A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 634b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 634B. (1) IF AN INDIVIDUAL IS REMOVED FROM THE OFFICE OF
- 2 STATE SENATOR OR REPRESENTATIVE AS PROVIDED IN SECTION 177 AND THE
- 3 GOVERNOR DIRECTS THAT THE VACANCY BE FILLED AT A SPECIAL ELECTION
- 4 IN THAT SENATORIAL OR REPRESENTATIVE DISTRICT, THIS STATE SHALL
- 5 REIMBURSE EACH COUNTY, CITY, OR TOWNSHIP FOR THE COST OF CONDUCTING
- 6 THE SPECIAL ELECTION. THE REIMBURSEMENT MUST NOT EXCEED THE
- 7 VERIFIED ACCOUNT OF ACTUAL COSTS OF THE SPECIAL ELECTION AS
- 8 PROVIDED IN THIS SECTION.
  - (2) PAYMENT MUST BE MADE UPON PRESENTATION AND APPROVAL OF A

- 15 (5) IF THIS STATE DISAPPROVES ALL OR A PORTION OF A VERIFIED
- 16 ACCOUNT OF ACTUAL COSTS UNDER SUBSECTION (4), THIS STATE SHALL SEND
- 17 A NOTICE OF DISAPPROVAL ALONG WITH THE REASONS FOR THE DISAPPROVAL
- 18 TO THE COUNTY, CITY, OR TOWNSHIP. UPON REQUEST OF A COUNTY, CITY,
- 19 OR TOWNSHIP WHOSE VERIFIED ACCOUNT OR PORTION OF A VERIFIED ACCOUNT
- 20 WAS DISAPPROVED UNDER THIS SECTION, THIS STATE SHALL REVIEW THE
- 21 DISAPPROVED COSTS WITH THE COUNTY, CITY, OR TOWNSHIP.
