A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 48729 (MCL 324.48729), as amended by 2012 PA
337.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 48729. (1) A EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION

 (2), A person shall not do any of the following:
 - (a) Take or possess minnows, wigglers, or crayfish for commercial purposes from any of the waters over which this state has jurisdiction; import minnows, wigglers, or crayfish for commercial purposes from outside of this state; or transport minnows, wigglers, or crayfish without having first procured a license as provided in section 48732. A license, except a license

- 1 to fish in the waters of this state as provided in part 435, is not
- 2 required of persons taking minnows, wigglers, or crayfish for their
- 3 individual use for bait. A person shall not set or use minnow traps
- 4 for the taking of minnows, wigglers, or crayfish for any purpose
- 5 unless the name and address of the user is on the trap.
- 6 (b) Export out of this state any minnows, wigglers, or
- 7 crayfish, dead or alive, taken either in or outside of this state
- 8 unless that person holds a permit issued under this subdivision.
- 9 The department, upon receipt of a payment of \$25.00, may issue a
- 10 permit, revocable by the department, under such ANY regulations as
- 11 the department prescribes, to any resident licensed as provided for
- 12 in section 48732, enabling that person to transport outside of this
- 13 state minnows, wigglers, or crayfish that were harvested from
- 14 waters outside of Michigan's THIS STATE'S jurisdictional border and
- 15 imported wholesale across that border. Minnows, wigglers, and
- 16 crayfish taken from Michigan's jurisdictional waters OVER WHICH

- 18 Imported wholesale minnows, wigglers, and crayfish shall MUST be

- 13 PURPOSES WITHOUT A PERMIT OR LICENSE IF THAT PERSON HAS PURCHASED
- 14 THE MINNOWS FROM ANOTHER PERSON THAT HOLDS A PERMIT OR LICENSE TO
- 15 TAKE, POSSESS, OR TRANSPORT THOSE MINNOWS.
