## **HOUSE BILL No. 6540**

November 28, 2018, Introduced by Rep. Marino and referred to the Committee on Insurance.

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

by amending section 3009 (MCL 500.3009), as amended by 2016 PA 346.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3009. (1) An INSURER SHALL NOT DELIVER OR ISSUE FOR
- 2 DELIVERY IN THIS STATE AN automobile liability or motor vehicle
- 3 liability policy insuring against loss resulting from liability
- 4 imposed by law for property damage, bodily injury, or death
- 5 suffered by any A person arising out of the ownership, maintenance,
- 6 or use of a motor vehicle shall not be delivered or issued for
- 7 delivery in this state with respect to any A motor vehicle
- registered or principally garaged in this state unless the
- 9 liability coverage is subject to all of the following limits:

- 1 (a) A limit, exclusive of interest and costs, of not less than
- \$\$20,000.00 \$\$200,000.00\$ because of bodily injury to or death of 1
- 3 person in any 1 accident.
- 4 (b) Subject to the limit for 1 person in subdivision (a), a
- 5 limit of not less than \$40,000.00\$ -\$300,000.00 because of bodily
- 6 injury to or death of 2 or more persons in any 1 accident.
- 7 (c) A limit of not less than \$10,000.00 because of injury to
- 8 or destruction of property of others in any accident.
- 9 (2) If authorized by the insured, automobile liability or
- 10 motor vehicle liability coverage may be excluded when a vehicle is
- 11 operated by a named person. An exclusion under this subsection is
- 12 not valid unless the following notice is on the face of the policy
- 13 or the declaration page or certificate of the policy and on the
- 14 certificate of insurance:
- 15 Warning—when a named excluded person operates a vehicle all
- 16 liability coverage is void—no one is insured. Owners of the vehicle
- 17 and others legally responsible for the acts of the named excluded
- 18 person remain fully personally liable.
- 19 (3) A liability policy described in subsection (1) may exclude
- 20 coverage for liability as provided in section 3017.
- 21 (4) If an insurer deletes coverages from an automobile
- 22 insurance policy pursuant to AS PROVIDED IN section 3101, the
- 23 insurer shall send documentary evidence of the deletion to the
- 24 insured.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
