

HOUSE BILL No. 6580

December 4, 2018, Introduced by Reps. Anthony, Sabo, LaGrand, Camilleri, Brinks, Love, Durhal, Sowerby, Gay-Dagnogo, Hoadley, Lasinski, Greimel, Zemke, Yancey, Garrett, Geiss, Brann, Faris, Chang, Neeley and Jones and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1921 PA 352, entitled

"An act to prohibit the marriage of a person under 16 years of age and to declare the marriage void,"

by amending section 1 (MCL 551.51), as amended by 1983 PA 198.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

HOUSE BILL No. 6580

1 Sec. 1. ~~(1) A marriage in this state shall not be contracted~~
2 ~~by a person who is under 16 years of age, and the marriage, if~~

8 Enacting section 1. This amendatory act takes effect 90 days
