

HOUSE BILL No. 6581

December 4, 2018, Introduced by Rep. Howrylak and referred to the Committee on Law and Justice.

A bill to amend 1961 PA 236, entitled "Revised judiciary act of 1961," by amending section 1019 (MCL 600.1019), as amended by 2002 PA 682.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1019. (1) The Michigan judicial institute shall provide
2 appropriate training for all probate judges and circuit judges who
3 are serving pursuant to the family court plan.

4 (2) **IN ADDITION TO THE TRAINING DESCRIBED IN SUBSECTION (1),**
5 **THE MICHIGAN JUDICIAL INSTITUTE SHALL PROVIDE APPROPRIATE TRAINING**
6 **FOR ALL PROBATE JUDGES, CIRCUIT JUDGES, COURT ADMINISTRATORS, COURT**
7 **STAFF MEMBERS, AND OTHER JUVENILE JUSTICE STAKEHOLDERS WHO ARE**
8 **SERVING PURSUANT TO THE FAMILY COURT PLAN OR WORKING WITHIN THE**
9 **FAMILY DIVISION OF CIRCUIT COURT ON MATTERS INVOLVING JUVENILES**
10 **UNDER CHAPTER XIIA OF THE PROBATE CODE OF 1939, 1939 PA 288, MCL**

2 (3) THE TRAINING PROVIDED UNDER SUBSECTION (2) MUST INCLUDE,
3 BUT NEED NOT BE LIMITED TO, TRAINING REGARDING THE USE OF VALIDATED
4 RISK AND NEEDS ASSESSMENTS AND APPROPRIATE DOSAGES FOR THE USE OF
5 TREATMENT UTILIZING MEDICATION.

6 (4) THE MICHIGAN JUDICIAL INSTITUTE JUVENILE JUSTICE TRAINING
7 FUND IS CREATED WITHIN THE STATE TREASURY.

8 (5) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM
9 ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL
10 DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT
11 TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.

12 (6) MONEY IN THE FUND AT THE CLOSE THE FISCAL YEAR SHALL
13 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.

14 (7) THE SUPREME COURT SHALL EXPEND MONEY FROM THE FUND, UPON
15 APPROPRIATION, TO PAY THE COSTS OF PROVIDING THE TRAINING REQUIRED
16 UNDER SUBSECTION (2).

17 Enacting section 1. This amendatory act takes effect 90 days
18 after the date it is enacted into law.
