A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 1086.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1086. (1) THE CIRCUIT COURT IN ANY JUDICIAL CIRCUIT MAY
- 2 ADOPT OR INSTITUTE A SWIFT AND SURE SANCTIONS COURT, BY STATUTE OR
- 3 COURT RULE.
 - (2) A SWIFT AND SURE SANCTIONS COURT SHALL CARRY OUT THE PURPOSES OF THE SWIFT AND SURE SANCTIONS ACT, CHAPTER XIA OF THE CODE OF CRIMINAL PROCEDURE, 1927 PA 175, MCL 771A.1 TO 771A.8.
 - (3) A CIRCUIT COURT THAT HAS ADOPTED A SWIFT AND SURE

 SANCTIONS COURT MAY ACCEPT PARTICIPANTS FROM ANY OTHER JURISDICTION

 IN THIS STATE BASED UPON EITHER THE RESIDENCE OF THE PARTICIPANT IN
