## **SENATE BILL No. 131**

February 9, 2017, Introduced by Senator HILDENBRAND and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 11, 17b, 201, and 236 (MCL 388.1611,
388.1617b, 388.1801, and 388.1836), sections 11, 201, and 236 as
amended by 2016 PA 249 and section 17b as amended by 2007 PA 137.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 11. (1) For the fiscal year ending September 30, 2016, there is appropriated for the public schools of this state and certain other state purposes relating to education the sum of \$11,905,439,300.00 from the state school aid fund and the sum of \$55,100,000.00 from the general fund. For the fiscal year ending September 30, 2017, 2018, there is appropriated for the public schools of this state and certain other state purposes relating to

education the sum of \$12,052,309,300.00 \$ from the 1 state school aid fund, the sum of \$218,900,000.00 \$ 2 from the general fund, AND an amount not to exceed \$72,000,000.00 3 4 \$ from the community district education trust fund 5 created under section 12 of the Michigan trust fund act, 2000 PA 6 489, MCL 12.262. , and an amount not to exceed \$100.00 from the water emergency reserve fund. In addition, all other available 7 federal funds are appropriated each fiscal year for the fiscal 8 9 years YEAR ending September 30, 2016 and September 30, 2017.2018. 10 (2) The appropriations under this section shall be allocated 11 as provided in this article. Money appropriated under this section 12 from the general fund shall be expended to fund the purposes of 13 this article before the expenditure of money appropriated under this section from the state school aid fund. 14 (3) Any general fund allocations under this article that are 15 16 not expended by the end of the state fiscal year are transferred to 17 the school aid stabilization fund created under section 11a. Sec. 17b. (1) Not later than October 20, November 20, December 18 19 20, January 20, February 20, March 20, April 20, May 20, June 20, 20 July 20, and August 20, the department shall prepare electronic files of the amount to be distributed under this act in the 21 installment to the districts and intermediate districts and deliver 22 23 the electronic files to the state treasurer, and the state 24 treasurer shall pay the installments on each of those dates or, if 25 the date is not a business day, on the next business day following that date. Except as otherwise provided in this act, the portion of 26 27 the district's or intermediate district's state fiscal year

- 1 entitlement to be included in each installment shall be 1/11. A
- 2 district or intermediate district shall accrue the payments
- 3 received in July and August to the school fiscal year ending the

- 4 earlier than the established payment date for those funds.
