SENATE BILL No. 337

April 27, 2017, Introduced by Senators O'BRIEN, JONES and SCHUITMAKER and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 136.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 136. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON SHALL NOT KNOWINGLY CIRCUMCISE, EXCISE, OR INFIBULATE ALL OR
- 3 ANY PART OF THE LABIA MAJORA OR LABIA MINORA OR CLITORIS OF ANOTHER
- 4 PERSON WHO IS LESS THAN 18 YEARS OF AGE. A PERSON WHO VIOLATES THIS
- 5 SECTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
 - MORE THAN 15 YEARS.
 - (2) A SURGICAL OPERATION IS NOT A VIOLATION OF THIS SECTION IF EITHER OF THE FOLLOWING CONDITIONS APPLIES:
 - (A) THE SURGICAL OPERATION IS NECESSARY TO THE HEALTH OF THE

- 1 PERSON ON WHOM IT IS PERFORMED, AND IT IS PERFORMED BY A LICENSED
- 2 MEDICAL PRACTITIONER.
- 3 (B) THE SURGICAL OPERATION IS PERFORMED ON A PERSON IN LABOR
- 4 OR WHO HAS JUST GIVEN BIRTH AND IS PERFORMED FOR MEDICAL PURPOSES
- 5 CONNECTED WITH THAT LABOR OR BIRTH BY A LICENSED MEDICAL
- 6 PRACTITIONER, MIDWIFE, OR PERSON IN TRAINING TO BECOME A LICENSED
- 7 MEDICAL PRACTITIONER OR LICENSED MIDWIFE.
- 8 (3) IT IS NOT A DEFENSE TO PROSECUTION UNDER THIS SECTION THAT
- 9 THE PERSON ON WHOM THE OPERATION IS PERFORMED OR IS TO BE
- 10 PERFORMED, OR ANY OTHER PERSON, BELIEVES THAT THE SURGICAL
- 11 OPERATION IS REQUIRED AS A MATTER OF CUSTOM OR RITUAL.
- 12 (4) AS USED IN THIS SECTION:
- 13 (A) "LICENSED MEDICAL PRACTITIONER" MEANS A MEDICAL PHYSICIAN
- 14 OR OSTEOPATHIC PHYSICIAN WHO IS LICENSED UNDER ARTICLE 15 OF THE
- 15 PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO 333.18838.
- 16 (B) "LICENSED MIDWIFE" MEANS A MIDWIFE LICENSED UNDER ARTICLE
- 17 15 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO
- 18 333.18838.
- 19 (C) "PERSON IN TRAINING" MEANS AN INDIVIDUAL ACTING UNDER THE
- 20 DELEGATORY AUTHORITY AND SUPERVISION OF A PHYSICIAN UNDER SECTION
- 21 16215(2) OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16215.
- 22 PERSON IN TRAINING INCLUDES, BUT IS NOT LIMITED TO, AN INDIVIDUAL
- 23 DESCRIBED IN SECTION 16215(3) OF THE PUBLIC HEALTH CODE, 1978 PA
- 24 368, MCL 333.16215, BUT DOES NOT INCLUDE AN INDIVIDUAL WHOSE
- 25 LICENSE HAS BEEN SUSPENDED UNDER ARTICLE 15.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.
