## **SENATE BILL No. 354**

May 2, 2017, Introduced by Senators PROOS, JONES, KNEZEK, HANSEN, MARLEAU and BRANDENBURG and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 8111.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811ll. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 3 RECOGNIZING THE KNIGHTS OF COLUMBUS. THE SECRETARY OF STATE IN
- 4 CONJUNCTION WITH THE KNIGHTS OF COLUMBUS SHALL DESIGN THE FUND-
- 5 RAISING PLATES AUTHORIZED IN THIS SECTION.
- 6 (2) THE KNIGHTS OF COLUMBUS FUND IS CREATED WITHIN THE STATE
- 7 TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
- 8 FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER
- 9 SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL
- 10 CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
  - MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN

- 1 THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND. THE STATE
- 2 TREASURER SHALL BE THE ADMINISTRATOR OF THE FUND FOR AUDITING
- 3 PURPOSES.
- 4 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 5 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE KNIGHTS OF
- 6 COLUMBUS TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION
- 7 MONEY TO THE FUND ESTABLISHED UNDER SUBSECTION (2).
- 8 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 9 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE
- 10 KNIGHTS OF COLUMBUS.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
