SENATE BILL No. 366

May 4, 2017, Introduced by Senators SCHMIDT, COLBECK, HORN, PROOS, MACGREGOR, SHIRKEY, GREEN, CASPERSON and STAMAS and referred to the Committee on Judiciary.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending sections 5b, 5c, and 5l (MCL 28.425b, 28.425c, and 28.425l), section 5b as amended by 2015 PA 207 and sections 5c and 5l as amended by 2015 PA 3.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5b. (1) Until November 30, 2015, to obtain a license to carry a concealed pistol, an individual shall apply to the

- 1 concealed weapon licensing board in the county in which that
- 2 individual resides. Beginning December 1, 2015, to TO obtain a
- 3 license to carry a concealed pistol, an individual shall apply to
- 4 the county clerk in the county in which the individual resides. The
- 5 applicant shall file the application with the county clerk in the
- 6 county in which the applicant resides during the county clerk's
- 7 normal business hours. The application shall MUST be on a form
- 8 provided by the director of the department of state police . Until
- 9 November 30, 2015, the application shall allow the applicant to
- 10 designate whether the applicant seeks a temporary license.
- 11 Beginning December 1, 2015, the application shall AND allow the
- 12 applicant to designate whether the applicant seeks an emergency
- 13 license OR A PROVISIONAL LICENSE. The APPLICANT SHALL SIGN THE
- 14 application shall be signed under oath. by the applicant. The
- 15 COUNTY CLERK OR HIS OR HER REPRESENTATIVE SHALL ADMINISTER THE
- 16 oath. shall be administered by the county clerk or his or her
- 17 representative. Beginning December 1, 2015, not AN APPLICANT SHALL
- 18 NOT SUBMIT more than 1 application may be submitted under this
- 19 subsection in any calendar year. Beginning December 1, 2015, an AN
- 20 application under this subsection is not considered complete until
- 21 an applicant submits all of the required information and fees and
- 22 has fingerprints taken under subsection (9). Beginning December 1,
- 23 2015, an AN application under this subsection is considered
- 24 withdrawn if an applicant does not have fingerprints taken under
- 25 subsection (9) within 45 days of the date an application is filed
- 26 under this subsection. Beginning December 1, 2015, a A completed
- 27 application under this section expires 1 year from the date of

- 1 application. Beginning December 1, 2015, the THE county clerk shall
- 2 issue the applicant a receipt for his or her application at the
- 3 time the application is submitted containing the name of the
- 4 applicant, the applicant's state-issued driver license or personal
- 5 identification card number, the date and time the receipt is
- 6 issued, the amount paid, the name of the county in which the
- 7 receipt is issued, an impression of the county seal, and the
- 8 statement, "This receipt was issued for the purpose of applying for
- 9 a concealed pistol license and for obtaining fingerprints related
- 10 to that application. This receipt does not authorize an individual
- 11 to carry a concealed pistol in this state.". The application shall
- 12 MUST contain all of the following:
- 13 (a) The applicant's legal name, date of birth, the address of
- 14 his or her primary residence, and , beginning December 1, 2015, his
- 15 or her state-issued driver license or personal identification card
- 16 number. Until November 30, 2015, if the applicant resides in a
- 17 city, village, or township that has a police department, the name
- 18 of the police department.
- 19 (b) A statement by the applicant that the applicant meets the
- 20 criteria for a license under this act to carry a concealed pistol.
- 21 (c) Until November 30, 2015, a statement by the applicant
- 22 authorizing the concealed weapon licensing board to access any
- 23 record, including any medical record, pertaining to the applicant's
- 24 qualifications for a license to carry a concealed pistol under this
- 25 act. The applicant may request that information received by the
- 26 concealed weapon licensing board under this subdivision be reviewed
- 27 in a closed session. If the applicant requests that the session be

- 1 closed, the concealed weapon licensing board shall close the
- 2 session only for purposes of this subdivision. The applicant and
- 3 his or her representative have the right to be present in the
- 4 closed session. Beginning December 1, 2015, a A statement by the
- 5 applicant authorizing the department of state police to access any
- 6 record needed to perform the verification in subsection (6).
- 7 (d) A statement by the applicant regarding whether he or she
- 8 has a history of mental illness that would disqualify him or her
- $\mathbf{9}$ under subsection (7)(j) to (l) from receiving a license to carry a
- 10 concealed pistol.
- 11 (e) A statement by the applicant regarding whether he or she
- 12 has ever been convicted in this state or elsewhere for any of the
- 13 following:
- 14 (i) Any felony.
- 15 (ii) A misdemeanor listed under subsection (7)(h) if the
- 16 applicant was convicted of that misdemeanor in the 8 years
- 17 immediately preceding the date of the application, or a misdemeanor
- 18 listed under subsection (7)(i) if the applicant was convicted of
- 19 that misdemeanor in the 3 years immediately preceding the date of
- 20 the application.
- 21 (f) A statement by the applicant whether he or she has been
- 22 dishonorably discharged from the United States armed forces.ARMED
- 23 FORCES.
- 24 (g) Until November 30, 2015, if the applicant seeks a
- 25 temporary license, the facts supporting the issuance of that
- 26 temporary license.
- 27 (h) Until November 30, 2015, the names, residential addresses,

- 1 and telephone numbers of 2 individuals who are references for the
- 2 applicant.
- 3 (G) (i) Until November 30, 2015, a passport-quality photograph
- 4 of the applicant provided by the applicant at the time of
- 5 application. Beginning December 1, 2015, if IF an applicant does
- 6 not have a digitized photograph on file with the secretary of
- 7 state, a passport-quality photograph of the applicant provided by
- 8 the applicant at the time of application.
- 9 (H) (j) A certificate stating that the applicant has completed
- 10 the training course prescribed by this act.
- 11 (2) The county clerk shall not require the applicant to submit
- 12 any additional forms, documents, letters, or other evidence of
- 13 eligibility for obtaining a license to carry a concealed pistol
- 14 except as set forth in subsection (1) or as otherwise provided for
- 15 in this act. The application form shall MUST contain a conspicuous
- 16 warning that the application is executed under oath and that
- 17 intentionally making a material false statement on the application
- 18 is a felony punishable by imprisonment for not more than 4 years or
- 19 a fine of not more than \$2,500.00, or both.
- 20 (3) An individual who intentionally makes a material false
- 21 statement on an application under subsection (1) is guilty of a
- 22 felony punishable by imprisonment for not more than 4 years or a
- fine of not more than \$2,500.00, or both.
- 24 (4) The county clerk shall retain a copy of each application
- 25 for a license to carry a concealed pistol as an official record.
- 26 One year after the expiration of a concealed pistol license, the
- 27 county clerk may destroy the record and maintain only a name index

1 of the record.

2 (5) Until November 30, 2015, each applicant shall pay a nonrefundable application and licensing fee of \$105.00 by any 3 4 method of payment accepted by that county for payments of other fees and penalties. Beginning December 1, 2015, each EACH applicant 5 shall pay an application and licensing fee of \$100.00 by any method 6 of payment accepted by that county for payments of other fees and 7 penalties. Except as provided in subsection (9), no other charge, 8 fee, cost, or assessment, including any local charge, fee, cost, or 9 assessment, is required of the applicant except as specifically 10 11 authorized in this act. The APPLICANT SHALL PAY THE application and 12 licensing fee shall be payable to the county. Until November 30, 13 2015, the county treasurer shall deposit \$15.00 of each application 14 and licensing fee collected under this section in the general fund 15 of the county and credit that deposit to the credit of the county sheriff and deposit \$26.00 of each fee collected under this section 16 17 in the concealed pistol licensing fund of that county created in section 5x. Beginning December 1, 2015, the THE county treasurer 18 19 shall deposit \$26.00 of each application and licensing fee 20 collected under this section in the concealed pistol licensing fund 21 of that county created in section 5x. The county treasurer shall 22 forward the balance remaining to the state treasurer. The state 23 treasurer shall deposit the balance of the fee in the general fund 24 to the credit of the department of state police. The department of 25 state police shall use the money received under this act to process 26 the fingerprints and to reimburse the Federal Bureau of 27 Investigation for the costs associated with processing fingerprints

- 1 submitted under this act. The balance of the money received under
- 2 this act shall MUST be credited to the department of state police.
- 3 (6) Until November 30, 2015, the county sheriff on behalf of
- 4 the concealed weapon licensing board shall verify the requirements
- 5 of subsection (7)(d), (e), (f), (h), (i), (j), (k), (l), and (m)
- 6 through the law enforcement information network and report his or
- 7 her finding to the concealed weapon licensing board. Beginning
- 8 December 1, 2015, the THE department of state police shall verify
- 9 the requirements of subsection (7)(d), (e), (f), (h), (i), (j),
- 10 (k), and (m) through the law enforcement information network and
- 11 the national instant criminal background check system and shall
- 12 report to the county clerk all statutory disqualifications, if any,
- 13 under this act that apply to an applicant. Until November 30, 2015,
- 14 if the applicant resides in a city, village, or township that has a
- 15 police department, the concealed weapon licensing board shall
- 16 contact that city, village, or township police department to
- 17 determine only whether that city, village, or township police
- 18 department has any information relevant to the investigation of
- 19 whether the applicant is eligible under this act to receive a
- 20 license to carry a concealed pistol. Until November 30, 2015, the
- 21 concealed weapon licensing board may require a person claiming
- 22 active duty status with the United States armed forces under this
- 23 section to provide proof of 1 or both of the following:
- 24 (a) The person's home of record.
- 25 (b) Permanent active duty assignment in this state.
- 26 (7) Until November 30, 2015, the concealed weapon licensing
- 27 board and, beginning December 1, 2015, the THE county clerk shall

- 1 issue and shall send by first-class mail a license to an applicant
- 2 to carry a concealed pistol within the period required under this
- 3 act if the concealed weapon licensing board or county clerk
- 4 determines that all of the following circumstances exist:
- 5 (a) The applicant is 21 years of age or older, OR IF THE
- 6 APPLICANT IS APPLYING FOR A PROVISIONAL LICENSE, THE APPLICANT IS
- 7 AT LEAST 18 YEARS OLD BUT LESS THAN 21 YEARS OLD.
- 8 (b) The applicant is a citizen of the United States or is an
- 9 alien lawfully admitted into the United States, is a legal resident
- 10 of this state, and has resided in this state for not less than the
- 11 6 months immediately preceding the date of application. Until
- 12 November 30, 2015, the concealed weapon licensing board may waive
- 13 the 6-month residency requirement for a temporary license under
- 14 section 5a(8) if the concealed weapon licensing board determines
- 15 that there is probable cause to believe that the safety of the
- 16 applicant or the safety of a member of the applicant's family is
- 17 endangered by the applicant's inability to immediately obtain a
- 18 license to carry a concealed pistol. Until November 30, 2015, if
- 19 the applicant holds a valid concealed pistol license issued by
- 20 another state at the time the applicant's residency in this state
- 21 is established, the concealed weapon licensing board may waive the
- 22 6 month waiting period and the applicant may apply for a concealed
- 23 pistol license at the time the applicant's residency in this state
- 24 is established. Until November 30, 2015, the concealed weapon
- 25 licensing board shall immediately issue a temporary license to that
- 26 applicant. Until November 30, 2015, the temporary license is valid
- 27 until the concealed weapon licensing board decides whether to grant

- 1 or deny the application. Beginning December 1, 2015, the THE county
- 2 clerk shall waive the 6-month residency requirement for an
- 3 emergency license under section 5a(4) if the applicant is a
- 4 petitioner for a personal protection order issued under section
- 5 2950 or 2950a of the revised judicature act of 1961, 1961 PA 236,
- 6 MCL 600.2950 and 600.2950a, or if the county sheriff determines
- 7 that there is clear and convincing evidence to believe that the
- 8 safety of the applicant or the safety of a member of the
- 9 applicant's family or household is endangered by the applicant's
- 10 inability to immediately obtain a license to carry a concealed
- 11 pistol. Beginning December 1, 2015, if IF the applicant holds a
- 12 valid concealed pistol license issued by another state at the time
- 13 the applicant's residency in this state is established, the county
- 14 clerk shall waive the 6-month waiting period RESIDENCY REQUIREMENT
- 15 and the applicant may apply for a concealed pistol license at the
- 16 time the applicant's residency in this state is established. For
- 17 the purposes of this section, a person—AN INDIVIDUAL is considered
- 18 a legal resident of this state if any of the following apply:
- 19 (i) The person-INDIVIDUAL has a valid, lawfully obtained
- 20 driver license issued under the Michigan vehicle code, 1949 PA 300,
- 21 MCL 257.1 to 257.923, or official state personal identification
- 22 card issued under 1972 PA 222, MCL 28.291 to 28.300.
- 23 (ii) The $\frac{person}{INDIVIDUAL}$ is lawfully registered to vote in
- 24 this state.
- 25 (iii) The person-INDIVIDUAL is on active duty status with the
- 26 United States armed forces ARMED FORCES and is stationed outside of
- 27 this state, but the person's INDIVIDUAL'S home of record is in this

- 1 state.
- 2 (iv) The person-INDIVIDUAL is on active duty status with the
- 3 United States armed forces ARMED FORCES and is permanently
- 4 stationed in this state, but the person's INDIVIDUAL'S home of
- 5 record is in another state.
- 6 (c) The applicant has knowledge and has had training in the
- 7 safe use and handling of a pistol by the successful completion of a
- 8 pistol safety training course or class that meets the requirements
- 9 of section 5j.
- 10 (d) The applicant is not the subject of an order or
- 11 disposition under any of the following:
- 12 (i) Section 464a of the mental health code, 1974 PA 258, MCL
- **13** 330.1464a.
- 14 (ii) Section 5107 of the estates and protected individuals
- 15 code, 1998 PA 386, MCL 700.5107.

- 1 (f) The applicant has never been convicted of a felony in this
- 2 state or elsewhere, and a felony charge against the applicant is
- 3 not pending in this state or elsewhere at the time he or she
- 4 applies for a license described in this section.
- 5 (g) The applicant has not been dishonorably discharged from
- 6 the United States armed forces. ARMED FORCES.
- 7 (h) The applicant has not been convicted of a misdemeanor
- 8 violation of any of the following in the 8 years immediately
- 9 preceding the date of application and a charge for a misdemeanor
- 10 violation of any of the following is not pending against the

- 10 (1)(d) that the applicant does not have a diagnosis of mental
- 11 illness that includes an assessment that the individual presents a
- 12 danger to himself or herself or to another at the time the
- 13 application is made, regardless of whether he or she is receiving
- 14 treatment for that illness.
- 15 (m) The applicant is not under a court order of legal
- 16 incapacity in this state or elsewhere.
- 17 (n) The applicant has a valid state-issued driver license or
- 18 personal identification card.
- 19 (8) Upon entry of a court order or conviction of 1 of the
- 20 enumerated prohibitions for using, transporting, selling,
- 21 purchasing, carrying, shipping, receiving, or distributing a
- 22 firearm in this section the department of state police shall

- 19 (12) A license to carry a concealed pistol that is issued
- 20 based upon an application that contains a material false statement

- 24 issuance of a license within 45 days after the concealed weapon
- 25 licensing board receives the fingerprint comparison report provided
- 26 under subsection (10). Beginning December 1, 2015, and subject
- 27 SUBJECT to subsection (10), the department of state police shall

- 18 initial license or renewal license under this act shall mail the
- 19 license to the licensee by first-class mail in a sealed envelope.
- 20 Beginning December 1, 2015, upon—UPON payment of the fee under
- 21 subsection (15), a county clerk shall issue a replacement license
- 22 in person at the time of application for a replacement license
- 23 unless the applicant requests that it be delivered by first-class
- 24 mail.
- 25 (20) A county clerk, county sheriff, county prosecuting
- 26 attorney, police department, or the department of state police is
- 27 not liable for civil damages as a result of the issuance of a

- 1 license under this act to an individual who later commits a crime
- 2 or a negligent act.
- 3 (21) Beginning December 1, 2015, an AN individual licensed
- 4 under this act to carry a concealed pistol may voluntarily
- 5 surrender that license without explanation. Beginning December 1,
- 6 2015, a A county clerk shall retain a surrendered license as an
- 7 official record for 1 year after the license is surrendered.
- 8 Beginning December 1, 2015, if IF an individual voluntarily
- 9 surrenders a license under this subsection, the county clerk shall
- 10 notify the department of state police. Beginning December 1, 2015,
- 11 the THE department of state police shall enter into the law

- 10 Beginning on the date the department of state police establishes a
- 11 system under subsection (2), the department of state police shall
- 12 mail an applicant a receipt by first-class mail for his or her
- 13 renewal application submitted by first-class mail at the time the
- 14 application is received by the department of state police. The
- 15 receipt issued under this subsection shall MUST contain all of the
- 16 following:
- 17 (a) The name of the applicant.
- (b) The date and time the receipt is issued.
- 19 (c) The amount paid.
- 20 (d) Beginning December 1, 2015, the THE applicant's state-
- 21 issued driver license or personal identification card number.
- 22 (e) Until November 30, 2015, the statement that the receipt is
- 23 for a license renewal. Beginning December 1, 2015, the THE
- 24 statement "This receipt was issued for the purpose of renewal of a
- 25 concealed pistol license. As provided in section 5l of 1927 PA 372,
- 26 MCL 28.425l, this receipt shall serve as a concealed pistol license
- 27 for the individual named in the receipt when carried with the

- 1 expired license and is valid until a license or notice of statutory
- 2 disqualification is issued by the county clerk. This receipt does
- 3 not exempt the individual named in the receipt from complying with
- 4 all applicable laws for the purchase of firearms.".
- 5 (f) Until November 30, 2015, a statement of whether the
- 6 applicant qualifies for an extension under subsection (5).
- 7 (F) (g) The name of the county in which the receipt is issued,
- 8 if applicable.
- 9 (G) (h) An impression of the county seal, if applicable.
- 10 (4) Until November 30, 2018, a member of the United States
- 11 armed forces, ARMED FORCES, the United States armed forces reserve,
- 12 ARMED FORCES RESERVE, or the Michigan National Guard who is on
- 13 orders to a duty station outside of this state may submit his or
- 14 her application to renew a license to carry a concealed pistol by
- 15 first-class mail, containing the required fee, a notarized
- 16 application, the licensee's address of record within the state, the
- 17 licensee's orders to report to a duty station outside of this
- 18 state, and if the licensee desires to have his or her application
- 19 receipt, renewal license, or any other notices mailed to his or her
- 20 address of assignment or deployment, a letter requesting that
- 21 action including the address of assignment or deployment. If the
- 22 concealed weapon licensing board approves or a county clerk issues
- 23 a renewal license under this section, the county clerk shall send
- 24 the license to the licensee by first-class mail in a sealed
- 25 envelope. If the licensee is a member of the United States armed
- 26 forces, ARMED FORCES, the United States armed forces reserve, ARMED
- 27 FORCES RESERVE, or the Michigan National Guard who is on orders to

- 1 a duty station outside of this state and requests that his or her
- 2 license be sent to the address of assignment or deployment, the
- 3 county clerk shall mail the license to the licensee at the address
- 4 of assignment or deployment provided in the renewal application.
- 5 Until November 30, 2018, if a renewal application is submitted by a
- 6 member of the United States armed forces, ARMED FORCES, the United
- 7 States armed forces reserve, ARMED FORCES RESERVE, or the Michigan
- 8 National Guard who is on orders to a duty station outside of this
- 9 state, the county clerk shall mail a receipt to the licensee by
- 10 first-class mail.
- 11 (5) Until November 30, 2015, if the concealed weapon licensing
- 12 board fails to deny or issue a renewal license to the person within
- 13 60 days as required under subsection (4), the expiration date of
- 14 the current license is extended by 180 days or until the renewal
- 15 license is issued, whichever occurs first. This subsection does not
- 16 apply unless the person pays the renewal fee at the time the
- 17 renewal application is submitted and the person has submitted a
- 18 receipt from a police agency that confirms that a background check
- 19 has been requested by the applicant. Beginning December 1, 2015, if
- 20 IF an individual applies for a renewal license before the
- 21 expiration of his or her license, the expiration date of the
- 22 current license is extended until the renewal license or notice of
- 23 statutory disqualification is issued. Beginning December 1, 2015,
- 24 the THE county clerk shall notify the department of state police in
- 25 a manner prescribed by the department of state police after he or
- 26 she receives an application for renewal. Beginning December 1,
- 27 2015, the THE department of state police shall immediately enter

- 1 into the law enforcement information network the date that
- 2 application for renewal was submitted and that the renewal
- 3 application is pending.
- 4 (6) A person AN INDIVIDUAL carrying a concealed pistol after
- 5 the expiration date of his or her license under an extension under
- 6 subsection (5) shall keep the receipt issued by the county clerk
- 7 under subsection (3) and his or her expired license in his or her
- 8 possession at all times that he or she is carrying the pistol. For
- 9 the purposes of this act, the receipt is considered to be part of
- 10 the license to carry a concealed pistol until a renewal license is
- 11 issued or denied or a notice of statutory disqualification is
- 12 issued.
- 13 (7) The educational requirements under section 5b(7)(c) are
- 14 waived for an applicant who is a retired police officer or retired
- 15 law enforcement officer.
- 16 (8) The educational requirements under section 5b(7)(c) for an
- 17 applicant who is applying for a renewal of a license under this act
- 18 are waived except that the applicant shall certify that he or she
- 19 has completed at least 3 hours' review of the training described
- 20 under section 5b(7)(c) and has had at least 1 hour of firing range
- 21 time in the 6 months immediately preceding the subsequent
- 22 application. Beginning December 1, 2015, the THE educational and
- 23 firing range requirements of this subsection are met if the
- 24 applicant certifies on the renewal application form that he or she
- 25 has complied with the requirements of this subsection. Beginning
- 26 December 1, 2015, an AN applicant is not required to verify the
- 27 statements made under this subsection and is not required to obtain

- 1 a certificate or undergo training other than as required by this
- 2 subsection.
- 3 (9) An applicant who is applying for a renewal of a license
- 4 issued under section 5b is not required to have fingerprints taken
- 5 again under section 5b(9) if all of the following conditions have
- 6 been met:
- 7 (a) There has been established a system for the department of
- 8 state police to save and maintain in its automated fingerprint
- 9 identification system (AFIS) database all fingerprints that are
- 10 submitted to the department of state police under section 5b.
- 11 (b) The applicant's fingerprints have been submitted to and
- 12 maintained by the department of state police as described in
- 13 subdivision (a) for ongoing comparison with the automated
- 14 fingerprint identification system (AFIS) database.
