## **SENATE BILL No. 395**

May 23, 2017, Introduced by Senators HERTEL, ANANICH, HOOD, GREGORY, CONYERS, COLBECK and KNEZEK and referred to the Committee on Elections and Government Reform.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding sections 484a and 956a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 484A. (1) AN INDIVIDUAL WHO CIRCULATES OR WHO OBTAINS

  5 CONCERNING THE CONTENTS, PURPORT, OR EFFECT OF THE BALLOT QUESTION

  - (A) AN INDIVIDUAL WHO SIGNS THE BALLOT QUESTION PETITION.

- 14 PUBLISH, OR EXHIBIT A FALSE STATEMENT OR MISREPRESENTATION
- 15 CONCERNING THE CONTENTS, PURPORT, OR EFFECT OF THE RECALL FOR THE
- 16 PURPOSE OF OBTAINING AN INDIVIDUAL'S SIGNATURE ON THE RECALL
- 17 PETITION OR FOR THE PURPOSE OF PERSUADING OR INFLUENCING AN
- 18 INDIVIDUAL TO SIGN THE RECALL PETITION.
- 19 (3) AN INDIVIDUAL WHO CIRCULATES OR WHO OBTAINS SIGNATURES ON
- 20 A RECALL PETITION SHALL NOT INTENTIONALLY MAKE A FALSE, DECEPTIVE,
- 21 OR MISLEADING STATEMENT OR REPRESENTATION IN RESPONSE TO AN
- 22 ELECTOR'S INQUIRY AS TO WHETHER HE OR SHE IS A PAID SIGNATURE
- 23 GATHERER OR A VOLUNTEER SIGNATURE GATHERER.
- 24 (4) AN INDIVIDUAL WHO VIOLATES ANY PROVISION OF THIS SECTION
- 25 IS GUILTY OF A MISDEMEANOR.
- 26 Enacting section 1. This amendatory act takes effect 90 days
- 27 after the date it is enacted into law.
