SENATE BILL No. 460

June 14, 2017, Introduced by Senators ZORN and MARLEAU and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 82a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 82A. (1) A PERSON WHO DELIVERS A SCHEDULE 1 OR 2
- 2 CONTROLLED SUBSTANCE, OTHER THAN MARIHUANA, TO ANOTHER PERSON IN
- 3 VIOLATION OF SECTION 7401 OF THE PUBLIC HEALTH CODE, 1978 PA 368,
- 4 MCL 333.7401, THAT IS CONSUMED BY THAT PERSON OR ANY OTHER PERSON
- 5 AND THAT IS A CAUSE OF THE SERIOUS INJURY OF THAT PERSON OR OTHER
- FOR PERSON IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR 2
- 7 YEARS. UPON A SECOND CONVICTION UNDER THIS SUBSECTION, THE PERSON
- SHALL BE PUNISHED BY IMPRISONMENT FOR 5 YEARS. UPON A THIRD OR
- 9 SUBSEQUENT CONVICTION UNDER THIS SUBSECTION, THE PERSON SHALL BE
- 0 PUNISHED BY IMPRISONMENT FOR 10 YEARS.

- 1 (2) A TERM OF IMPRISONMENT PRESCRIBED BY THIS SECTION IS IN
- 2 ADDITION TO THE SENTENCE IMPOSED FOR THE CONVICTION OF DELIVERY OF
- 3 A SCHEDULE 1 OR 2 CONTROLLED SUBSTANCE AND MUST BE SERVED
- 4 CONSECUTIVELY WITH AND PRECEDING ANY TERM OF IMPRISONMENT IMPOSED

- 16 (A) LOSS OF A LIMB OR USE OF A LIMB.
- 17 (B) LOSS OF A HAND, FOOT, FINGER, OR THUMB OR USE OF A HAND,
- 18 FOOT, FINGER, OR THUMB.
- 19 (C) LOSS OF AN EYE OR EAR OR USE OF AN EYE OR EAR.
- 20 (D) LOSS OR SUBSTANTIAL IMPAIRMENT OF A BODILY FUNCTION.
- 21 (E) SERIOUS VISIBLE DISFIGUREMENT.
- 22 (F) A COMATOSE STATE THAT LASTS FOR MORE THAN 3 DAYS.
- 23 (G) MEASURABLE BRAIN DAMAGE OR MENTAL IMPAIRMENT.
- 24 (H) A SKULL FRACTURE OR OTHER SERIOUS BONE FRACTURE.
- 25 (I) SUBDURAL HEMORRHAGE OR HEMATOMA.
- 26 (J) LOSS OF CONSCIOUSNESS OR A LIFE-THREATENING DEPRESSION OF
- 27 THE CENTRAL NERVOUS SYSTEM RESULTING AFTER AN OPIOID ANTAGONIST IS

- 1 ADMINISTERED FOLLOWING AN OVERDOSE.
- 2 Enacting section 1. This amendatory act takes effect 90 days
- 3 after the date it is enacted into law.
