A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1171 (MCL 380.1171), as added by 2006 PA 324.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1171. (1) The board of a school district or board of
- 2 directors of a public school academy is encouraged to SHALL provide
- 3 age-appropriate AND MEDICALLY ACCURATE instruction for pupils and
- 4 MEDICALLY ACCURATE professional development for school personnel
- 5 concerning the warning signs and risk factors for suicide and
 - depression and the protective factors that help prevent suicide.
- 7 The instruction and professional development shall be designed to
- 8 achieve the following goals:
 - (a) To prevent both fatal and nonfatal suicide behaviors among

- 10 (3) The department shall develop or select model programs and
