SENATE BILL No. 548

September 12, 2017, Introduced by Senators COLBECK, PAVLOV and GREEN and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1210; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 1210. (1) FOR A SCHOOL DISTRICT, INTERMEDIATE SCHOOL

DISTRICT, OR PUBLIC SCHOOL ACADEMY TO BE ELIGIBLE TO RECEIVE FUNDS

FROM THE ENHANCED MICHIGAN EDUCATION SAVINGS PROGRAM ACCOUNTS UNDER

THE ENHANCED MICHIGAN EDUCATION SAVINGS PROGRAM ACT, NOT LATER THAN

MARCH 1, 2018 AND THEREAFTER, AT LEAST 6 MONTHS BEFORE THE START OF

EACH SCHOOL YEAR, THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE

SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY

SHALL SUBMIT TO THE DEPARTMENT AND THE DEPARTMENT OF TREASURY, IN

THE FORM AND MANNER PRESCRIBED BY THE DEPARTMENT AND THE DEPARTMENT

OF TREASURY, ALL OF THE FOLLOWING INFORMATION:

- 8 SERVICE.
- 9 (B) A BREAKDOWN OF THE DIRECT COSTS AND FULLY BURDENED COSTS
- 10 TO THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 11 SCHOOL ACADEMY FOR PROVIDING EACH OF THE SERVICES LISTED IN
- 12 SUBDIVISION (A).
- 13 (C) ANY OTHER INFORMATION REQUESTED BY THE DEPARTMENT OF
- 14 TREASURY RELATED TO SERVICES PROVIDED TO PUPILS BY THE SCHOOL
- 15 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY.
- 16 (2) THE DEPARTMENT AND A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 17 DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL ENSURE THAT PARENTS HAVE
- 18 ACCESS TO INFORMATION ON THE DIRECT COSTS AND FULLY BURDENED COSTS
- 19 OF EACH ELIGIBLE SERVICE.
- 20 (3) AT LEAST 6 MONTHS BEFORE THE START OF EACH SCHOOL YEAR, A
- 21 SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 22 ACADEMY SHALL PROVIDE TO PARENTS CLEAR INFORMATION ON WHICH
- 23 ELIGIBLE SERVICES ARE AVAILABLE FROM THE SCHOOL DISTRICT,
- 24 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY.
- 25 (4) AS USED IN THIS SECTION, "ELIGIBLE SERVICE" MEANS A
- 26 SERVICE THAT MAY BE PURCHASED USING AN ENHANCED MICHIGAN EDUCATION
- 27 SAVINGS PROGRAM ACCOUNT, AS PRESCRIBED BY THE DEPARTMENT UNDER THE
