- 1 solely for the transportation of pupils to or from school, school-

- 4 (k) A vehicle operated by a canoe or other watercraft,
- 5 bicycle, or horse livery that is used only to transport clients
- 6 between their primary business location and the launch or

- 8 (1) An interstate motor carrier of passengers operating under
- 9 a United States Department of Transportation, Federal Motor Carrier
- 10 Safety Administration (USDOT-FMCSA) certificate of authority THAT
- 11 IS PROVIDING A MULTISTATE REGULAR ROUTE SERVICE THAT PASSES THROUGH

- 14 (2) A motor carrier that is exempt under subsection (1) shall
- 15 operate under the requirements of this act when operating outside
- 16 of the exemptions described in subsection (1).
- 17 Enacting section 1. This amendatory act takes effect 90 days
- 18 after the date it is enacted into law.
